- Structural review and design of steel tube gates ranging from 6' wide to 34' (9 gates total)
  with ornamental aluminum panes covering the exterior of the gates. SE review will consist
  of design direction on the post size, frame sizing & geometry, and various connection
  details.
- Structural review and design of the aluminum fencing panels. This review will assess the panels thickness in relation to the perforation or openness of the panels as it relates to the wind speed requirements in South Florida. The goal is to determine a minimum and maximum perforation allowance to stay within the desired ¼" panel thickness, while meeting IBC for South Florida. Once a min-max perforation allowance is established, we will have a range of designs to choose.

    - Signed & sealed Structurally Engineered Drawings and Calculations for the typical fencing detail and gate design

- o DESIGN DRAWINGS: \$15,000.00
  - Typical panel showing the concrete, post, panel, and connection details as recommended by the SE review. We will also provide a layout for the panels and fence, along with a typical Gate detail showing the steel frame of the gate and the panel interface.
  - Includes the design of the water jet cut panels at 6' or 8' high and percentage of openness as allowed by SE calculations and/or required due to visibility of the amphitheater.
