**AMENDMENT NUMBER ONE (1)
STATE OF FLORIDA DEPARTMENT OF TRANSPORTATION, DISTRICT FOUR (4)
MAINTENANCE MEMORANDUM OF AGREEMENT (MMOA)**

THIS AMENDMENT Number One (1) to the Original Maintenance Memorandum of Agreement (MMOA), Permit # 2018-C-491-00007, dated 6/1/2020, made and entered into this _____ by and between the **STATE OF FLORIDA DEPARTMENT OF TRANSPORTATION** hereinafter called the **DEPARTMENT** and the **CITY OF HOLLYWOOD**, a municipal corporation existing under the Laws of Florida, hereinafter called the **AGENCY**.

WITNESSETH

WHEREAS, the parties entered into the Maintenance Memorandum of Agreement dated, June 1st 2020 for the purpose of requiring the **AGENCY** to install and maintain black color coated painted mast arm assemblies (includes upright pole and arm); and

WHEREAS, the **AGENCY** intends to install black color coated painted mast arm assemblies (includes upright pole and arm) along a portion of SR A1A/ North Ocean Boulevard at Nebraska Street, Carolina Street and Scott Street under **Permit # 2018-C-491-00007**, within the **DEPARTMENT'S** right-of-way; and

WHEREAS, it is the intent of the **AGENCY** and the **DEPARTMENT** that the **AGENCY** shall maintain: black color coated painted mast arm assemblies (includes upright pole and arm), hereinafter referred as "**IMPROVEMENTS**" within the project limits along State Road (S.R.) A1A from Mile Post (M.P.) 3.452 to M.P. 3.806; and

WHEREAS the installation of the **IMPROVEMENTS** pursuant to this Amendment extends the **AGENCY's** maintenance limits, as described in **Exhibit A**, of the Original Agreement dated June 1st, 2020; and

WHEREAS, the **AGENCY** by Resolution No. _____ dated _____, attached hereto and by this reference made a part hereof, desires to enter this MMOA Amendment and authorized its officers to do so.

NOW THEREFORE, for and in consideration of mutual benefits that flow each to the other, the parties covenant and agree as follows:

1. **Exhibit "A"** of the Maintenance Memorandum of Agreement dated June 1st, 2020, shall be amended to include the additional areas: of SR A1A from M.P. 3.452 to M.P. 3.806, as set forth in Exhibit A attached and incorporated into this Amendment.
2. The **AGENCY** shall construct and maintain the **IMPROVEMENTS** along SR A1A from M.P. 3.452 to M.P. 3.806 as set forth in **Exhibit A**, attached to this Amendment in accordance with the plans attached as **Exhibit B**.
3. The **AGENCY** shall agree to install and maintain the **IMPROVEMENTS** in this Amendment

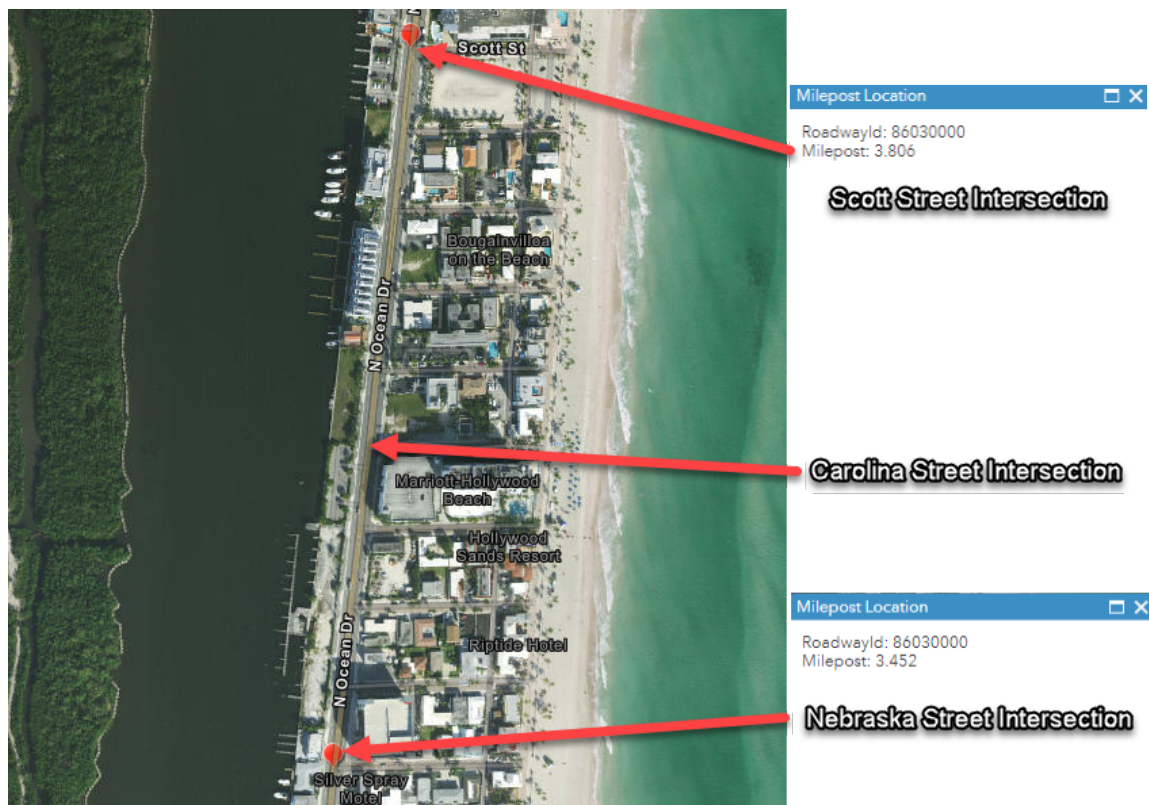

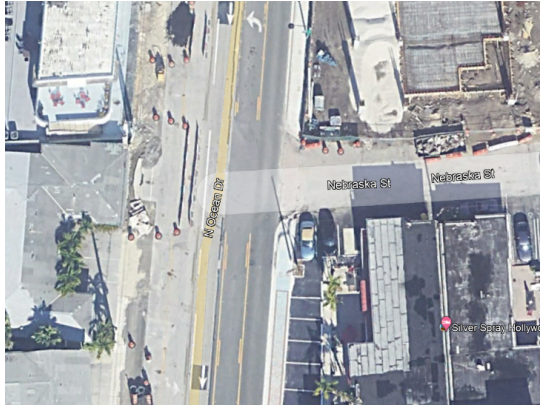
