A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, SUPPORTING THE REPURPOSING OF MOTOR VEHICLE LANES WITHIN THE DIXIE HIGHWAY CORRIDOR COMPLETE STREETS PROJECT IDENTIFIED IN THE BROWARD COUNTY METROPOLITAN ORGANIZATION COMPLETE STREETS MASTER PLAN.

WHEREAS, the City Commission supports the implementation of complete streets for safe travel and access by all users utilizing varying modes of transportation and to promote a safe, healthy, livable and sustainable community, including the Dixie Highway/21st Avenue corridor; and

WHEREAS, the Dixie Highway/21st Avenue corridor is a Broward County public roadway, with final permit authority resting with Broward County and its agencies; and

WHEREAS, the City Commission passed and adopted Resolution No. R-2014-082, recommending an amendment to the Broward County Trafficways Plan to add the Context "Sensitive Corridor" Designation to a portion of Dixie Highway/21st Avenue between Pembroke Road and Sheridan Street, in order to facilitate the implementation of Complete Streets Solutions; and

WHEREAS, on August 28, 2014, the Broward County Planning Council approved Agenda Item PH7 relating to an amendment to the Trafficways Plan that assigned the Context "Sensitive Corridor" designation for Dixie Highway/21st Avenue from Sheridan Street to Pembroke Road; and

WHEREAS, the Broward Metropolitan Planning Organization ("MPO") identified the Dixie Highway corridor as a priority project within the Complete Streets Master Plan ("CSMP") adopted in February 2019; and

WHEREAS, on June 19, 2019, the City Commission passed and adopted Resolution No. R-2019-173, supporting the Dixie Highway/21st Avenue Complete Streets Project and endorsing FDOT's delivery of certain complete street projects identified in the MPO CSMP as a high priority corridor in order to be included in the FDOT five-year adopted work program; and

WHEREAS, in June 2019, the Broward County Complete Streets Team recommended that the traffic study advance to the Broward County Commission; and

WHEREAS, in November, 2019, the Broward County Commission considered the traffic study and the County Commission required that additional public engagement activities occur before considering the item for approval; and

WHEREAS, on February 17, 2021, the City Commission passed and adopted Resolution No. R-2021-033, authorizing Kimley-Horn and Associates, Inc. to provide professional engineering services to assist the City with the additional public engagement efforts for the Dixie Highway Corridor from Sheridan Street to Pembroke Road as required by Broward County; and

WHEREAS, on September 28, 2021, the City, the Hollywood Community Redevelopment Agency, and the City of Hallandale Beach jointly conducted a public meeting in accordance with Broward County's municipal-level Community Awareness Plan guidelines for lane elimination proposals; and

WHEREAS, the MPO requires that the City Commission pass and adopt a Resolution supporting the re-purposing of motor vehicle lanes within the Dixie Highway Corridor between Sheridan Street and Pembroke Road for the purpose of a Complete Streets conversion.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

<u>Section 2</u>: That it supports the re-purposing of motor vehicle lanes within the Dixie Highway Corridor between Sheridan Street and Pembroke Road for the purpose of implementing a Complete Streets conversion.
