A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE THE ATTACHED CONTRACT BETWEEN PRECISION ROOFING CORP. AND THE CITY OF HOLLYWOOD FOR ROOF REPLACEMENT ON THE POLICE DEPARTMENT HEADQUARTERS BUILDING, IN THE AMOUNT OF \$176,900.00, WITH CONSTRUCTION TO START IN JULY 2014 AND AN ESTIMATED COMPLETION DATE IN AUGUST 2014.

WHEREAS, the Department of Public Works has determined that the high roof above the fourth floor on the Police Headquarters Building needs to be replaced; and

WHEREAS, specifications and details to replace the roof were prepared by City staff and the Notice to Bidders was advertised online via the City's website and DemandStar on May 8, 2014; and

WHEREAS, a Mandatory Pre-Bid Meeting was held at the site on May 22, 2014, and sixteen (16) contractors reviewed the existing conditions on the roof; and

WHEREAS, through receipt of the City's bid specifications for this project, all contractors have been provided with a copy of the City's contract, including the terms and conditions contained therein; and

WHEREAS, six (6) bids were received and publicly opened at 10:00 AM on May 30, 2014, and the responsive bids are as follows:

WHEREAS, City staff reviewed the six (6) bids and determined that the bid submitted by Precision Roofing Corp. (Precision) was the overall lowest, responsive and responsible bid, and have recommended the award of the bid to Precision in an amount not to exceed \$176,900.00; and

WHEREAS, funding for this project will become available upon the adoption and approval of the resolution amending the FY 2014 Capital Improvement Plan scheduled for the Commission agenda on June 18, 2014 and funding is to be allocated in an account to be established by the Department of Financial Services;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That it hereby approves and authorizes the execution, by the appropriate City Officials, of the attached contract between Precision Roofing Corp, Inc., and the City of Hollywood, together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form and legality by the City Attorney.

Section 2: That this resolution shall be in full force and effect immediately upon its passage and adoption.
