**SUBJECT:** Recommendation to approve the 1<sup>st</sup> renewal period; April 3, 2025 – April 2, 2026, to Rooster Concrete Corp. for concrete supply and delivery of ready-mix 3000 psi up to \$130,000.00.

**ISSUE:**

A Blanket Purchase Agreement PA600855 was approved by Resolution No. R-2024-139 on May 1, 2024, for concrete supply and delivery of ready-mix 3000 psi. The Public Works Department has a continued need for concrete supply and delivery of ready-mix 3000psi. Blanket Purchase Agreement PA600855 was approved for an Initial period April 3, 2024 – April 2, 2025 with three, one-year renewal options. Concrete supply and delivery of ready-mix 3000 psi provided by Rooster Concrete Corp. continues to be satisfactory.

**AUTHORITY:**

**§ 38.49 TERMINATION, EXTENSION AND RENEWAL OF CONTRACTS.**

**(C) Renewals:**

*When a contract entered into by the City pursuant to City Commission approval provides for one or more renewals by affirmative action of the City and the estimated annual cost of a renewal exceeds \$250,000, only the City Commission is authorized to*

*approve such renewals. When a contract entered into by the City pursuant to City Commission approval provides for one or more renewals by affirmative action of the City and the estimated annual cost of a renewal of the contract does not exceed \$250,000, the CPO shall have the authority to recommend to the City Manager approval or rejection of the renewal if it is the first, second, or third renewal of the contract, but only the City Commission is authorized to approve any subsequent renewal. When a contract entered into by the City pursuant to City Commission approval provides for one or more renewals by affirmative action of the City and the estimated annual cost of a renewal of the contract does not exceed \$25,000, the CPO shall have the authority to approve or reject the renewal if it is the first, second or third renewal of the contract, but only the City Commission is authorized to approve any subsequent renewal.*
