A RESOLUTION OF THE CITY COMMISSION OF THE CITY **AUTHORIZING** OF HOLLYWOOD, FLORIDA, APPROPRIATE CITY OFFICIALS TO ISSUE THE ATTACHED BLANKET PURCHASE ORDERS RENEWING THE AGREEMENTS BETWEEN CONDO ELECTRIC MOTOR REPAIR AND THE CITY OF HOLLYWOOD. MIAMI INDUSTRIAL MOTOR AND THE CITY OF HOLLYWOOD AND ACE PUMP AND SUPPLY AND THE CITY OF HOLLYWOOD FOR THE REPAIR OF ELECTRIC MOTORS FOR AN ESTIMATED ANNUAL TOTAL EXPENDITURE OF \$140,000.00.

WHEREAS, the Public Utilities Department requires one or more agreements for the repair of various electric motors throughout the City; and

WHEREAS, the repairs shall be classified as a rebuild or a reconditioning; and

WHEREAS, due to the wide variety of motors possibly needing repair, pricing was required and submitted as a percentage discount off the Vaughn's Price Guide for the Repair of Electric Motors as approved by the Electrical Apparatus Service Association (E.A.S.A.) as a national average standard pricing; and

WHEREAS, on February 20, 2013, the City Commission passed and adopted Resolution Number R-2013-041, authorizing the issuance of blanket purchase orders to Condo Electric Motor Repair (B002454), Miami Industrial Motor (B002453) and Ace Pump and Supply (B002452) for the repair of electric motors in accordance with bid number F-4346-13-JE, for a one (1) year period with the option to renew for two (2) additional one (1) year periods; and

WHEREAS, on March 19, 2014, the City Commission passed and adopted Resolution Number R-2014-066, renewing the blanket purchase orders to Condo Electric Motor Repair (B002454), Miami Industrial Motor (B002453) and Ace Pump and Supply (B002452) for the repair of electric motors in accordance with bid number F-4346-13-JE, for the first one (1) year renewal period with the option to renew for one (1) additional one (1) year period; and

WHEREAS, Condo Electric Motor Repair, Miami Industrial Motor and Ace Pump and Supply continue to repair electric motors for the City of Hollywood in a satisfactory manner and have all agreed to renew their respective contracts for an additional one (1) year period under the same terms, conditions and discounts of Bid Number F-4346-13-JE; and

WHEREAS, the Director of Pubic Utilities and the Director of Procurement Services recommend that the City Commission approve award of the attached Blanket Purchase Orders to Condo Electric Motor Repair of Hialeah, Florida in the estimated annual expenditure of \$100,500.00, Miami Industrial Motor of Doral, Florida in the estimated annual expenditure of \$10,000.00 and Ace Pump and Supply of Hollywood, Florida in the estimated annual expenditure of \$29,500.00 to renew for one (1) final one (1) year period in an estimated total annual expenditure of \$140,000.00; and

WHEREAS, funding for the attached blanket purchase orders has been provided for in the fiscal year 2015 budget in the Public Utilities Department's Maintenance – Machinery Account Numbers 42.4011.00765.536.004633, 42.4041.00784.536.005224, 42.4011.00762.536.004633, and 43.4031.00000.538.004633.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

- <u>Section 1:</u> That it hereby approves and authorizes the issuance, by the appropriate City Officials, of the attached Blanket Purchase Order between Condo Electric Motor Repair and the City of Hollywood, together with such non material changes as may be subsequently agreed to by the City Manager and approved as to form and legality by the City Attorney
- <u>Section 2:</u> That it hereby approves and authorizes the issuance, by the appropriate City Officials, of the attached Blanket Purchase Order between Miami Industrial Motor and the City of Hollywood, together with such non material changes as may be subsequently agreed to by the City Manager and approved as to form and legality by the City Attorney
- <u>Section 3:</u> That it hereby approves and authorizes the issuance, by the appropriate City Officials, of the attached Blanket Purchase Order between Ace Pump and Supply and the City of Hollywood, together with such non material changes as may be subsequently agreed to by the City Manager and approved as to form and legality by the City Attorney

<u>Section 4:</u> That this resolution shall be in full force and effect immediately upon its passage and adoption.
