A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, RATIFYING THE SUBMISSION OF AN APPLICATION TO THE FLORIDA INLAND NAVIGATIONAL DISTRICT 2024 WATERWAY ASSISTANCE PROGRAM GRANT FOR THE BOAT LIFT PROJECT IN THE APPROXIMATE AMOUNT OF \$50,000.00 WITH 50% MATCHING **FUNDS:** AUTHORIZING APPROPRIATE CITY OFFICIALS TO EXECUTE ALL GRANT DOCUMENTS.

WHEREAS, the Police Department applied for the Florida Inland Navigational District Waterway Assistance Program ("FIND WAP") grant seeking funding for the boat lift project at the Hollywood Marina; and

WHEREAS, the grant will be used to fund the installation of boat lift jet docks at the Hollywood Marina for storage of the police patrol vessel for an estimated project cost of \$100,000.00 to increase environmental sustainability and decrease response times; and

WHEREAS, the FIND WAP requires a one to one match equivalent to \$50,000.00 from the grant recipient, and the matching funds would be provided through use of Law Enforcement Forfeiture Funds; and

WHEREAS, the Chief of Police recommends that the appropriate City officials ratify the application for the Fiscal Year 2024 FIND WAP and further recommends the acceptance and execution of the grant upon its award.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

<u>Section 2</u>: That the City Manager is authorized to accept the grant, if awarded, provided that the City Manager shall have the discretion to refuse the grant if he determines it in the best interest of the City to do so, in which case he shall advise the City Commission of his intention to refuse the grant.

Section 3: That it authorizes the appropriate City officials to execute all grant documents upon receiving the grant funds, together with such non-material changes as may be acceptable to the City Manager and approved as to form by the City Attorney.
