A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE THE ATTACHED CONTRACT BETWEEN WEEKLEY ASPHALT PAVING, INC. AND THE CITY OF HOLLYWOOD, FOR STREET RESURFACING PROJECT BID NUMBER PW-14-022 AT VARIOUS LOCATIONS IN THE CITY OF HOLLYWOOD IN THE AMOUNT OF \$1,790,891.00.

WHEREAS, in order to reduce maintenance costs and provide a better level of service, the City of Hollywood maintains a program to resurface streets in the City based on the 2013 Pavement Management Study; and

WHEREAS, specifications for street resurfacing to implement the 2015 Citywide Street Resurfacing Project were prepared by the Engineering and Architectural Services Division; and

WHEREAS, through receipt of the City's bid specifications for this project, all prospective bidders were provided with a copy of the City's contract, including the terms and conditions contained therein; and

WHEREAS, the City Commission reserves the right to reject any part of any bid; and

WHEREAS, on December 22, 2014, the 2015 Citywide Street Resurfacing Project, Project Bid Number PW-14-022, was electronically advertised via BidSync on December 22, 2014 a Pre-Bid Meeting was held on January 20, 2015, and bid results were received on February 10, 2015 as listed below:

WHEREAS, Community Asphalt Corp., was determined to be non-responsive because the bid was not received within the specific deadline; and

WHEREAS, staff has reviewed all submitted bids and determined the bid received from Weekley Asphalt Paving, Inc. was the lowest responsive and responsible bid, and therefore, recommends the award of this contract to Weekley Asphalt Paving, Inc. in the amount of \$1,790,891.00; and

WHEREAS, award is subject to the City's receipt and approval of all insurance certificates and bonds required by the City's Risk Manager, and indemnity/indemnification to the City; and

WHEREAS, the City may terminate the agreement should the Contractor fail to reasonably perform the services as specified or without cause, upon thirty (30) days written notification; and

WHEREAS, on December 3, 2014 the City Commission approved R2014-356 which adopted the FY 2015 Capital Improvement Plan and included funding for a portion of the Street Resurfacing Program and funds are available in account number 34.1415.15304.541.006303; and

WHEREAS, on December 17, 2014 the City Commission approved R2014-374 which amending the Adopted FY 2015 Capital Improvement Plan to include the rollover of prior year CIP funds and included additional funding for the Street Resurfacing Program and funds are available in account numbers 34.1413.13304.541.006303 and 34.1414.14304.541.006303;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That it hereby approves and authorizes the execution by the appropriate City Officials, of the attached contract between Weekley Asphalt Paving, Inc. and the City of Hollywood, together with such non-material changes, as may be
