

ORDINANCE NO. _____

AN ORDINANCE OF THE CITY OF HOLLYWOOD, FLORIDA, CREATING SECTION 72.100 OF THE CODE OF ORDINANCES TO PROHIBIT PARKING OF CERTAIN VEHICLES ON PUBLIC PROPERTY EXCEPT IN BICYCLE RACKS, DOCKING STATIONS OR SIMILAR DEVICES.

WHEREAS, a bicycle, motorized scooter or go-ped parked on public property except in a bicycle rack, docking station or other device designed for the parking of such vehicle can obstruct the property, create an eyesore and result in injuries; and

WHEREAS, the City Commission wishes to address this problem by regulating the parking of these vehicles on public property;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That Section 72.100 of the Code of Ordinances is hereby created to read as follows:

TITLE VII: TRAFFIC CODE

CHAPTER 72: PARKING

* * *

REQUIRED PARKING OF CERTAIN VEHICLES
IN BICYCLE RACKS OR DOCKING STATIONS

§ 72.100 TRAFFIC REGULATIONS.

It shall be unlawful for any person to park a bicycle, motorized scooter or go-ped on public right-of-way or other public property except in a bicycle rack, docking station or other device designed for the parking of such vehicle.

ORDINANCE PROHIBITING PARKING OF CERTAIN VEHICLES ON PUBLIC PROPERTY EXCEPT IN BICYCLE RACKS, DOCKING STATIONS OR SIMILAR DEVICES.

Section 2: That it is the intention of the City Commission that the provisions of this Ordinance shall become and be made a part of the Code of Ordinances of the City of Hollywood, Florida, and the provisions of this Ordinance may be renumbered to accomplish such intention.

Section 3: That if any word, phrase, clause, subsection or section of this Ordinance is for any reason held unconstitutional or invalid, such invalidity shall not affect the validity of any remaining portions of this Ordinance.

Section 4: That all sections or parts of sections of the Code of Ordinances, all ordinances or parts of ordinances, and all resolutions or parts of resolutions in conflict are repealed to the extent of such conflict.

Section 5: That this Ordinance shall be in full force and effect immediately upon its passage and adoption.
