A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA RATIFYING THE SUBMITTAL OF AN APPLICATION TO THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT COMMUNITY PROJECT **FUNDING** GRANT PROGRAM FOR THE COASTAL RESILIENCY PHASE IV EAST-WEST STREETS (RESILIENCY AND HARDENING) PROJECT, IMPLEMENTING RESILIENCY AND FLOOD MANAGEMENT IMPROVEMENTS FOR COASTAL ECONOMIC VITALITY, INFRASTRUCTURE HARDENING, AND SAFETY FROM HARRISON STREET TO MAGNOLIA TERRACE BETWEEN STATE ROAD A1A AND THE BROADWALK IN AN AMOUNT UP TO \$500,000.00: AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE ALL APPLICABLE PROGRAM DOCUMENTS AND AGREEMENTS.

WHEREAS, the Community Redevelopment Agency ("CRA") has identified the Coastal Resiliency Phase IV E-W Streets (Resiliency and Hardening) from Harrison Street to Magnolia Terrace between State Road A1A and the Broadwalk ("Project") as a Capital Improvement Project; and

WHEREAS, the CRA Board approved the Capital Improvement Plan in September 2020, which included the Project; and

WHEREAS, this Project will include but is not limited to the following:

- Improving the existing drainage system and adjusting the profile of the E/W streets to mitigate flooding
- Harmonizing the public right-of-way and private property to reduce flooding
- Ensuring safety and safe conditions through infrastructure improvements
- Reducing runoff by increasing pervious areas
- Creating a safe and resilient environment which stimulates commercial redevelopment and revitalization
- Upgrading the level of service, accessibility and quality of life for residents and visitors

; and

WHEREAS, the Project improvements will mitigate flooding along the local street connectors, improve sunny day flooding by raising the east west streets and harmonize, and create safe access to and from State Road A1A, Florida Department of Transportation Right-Of-Way; and

WHEREAS, the Project was identified within the 1997 Hollywood Beach CRA Plan as it promotes redevelopment and eliminates the causes of physical and economic blight; and

WHEREAS, the City, on behalf of the CRA, applied for this grant in a total aggregate amount not to exceed \$500,000.00; and

WHEREAS, upon completion of the Project, the CRA will be responsible for operating and maintenance costs.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

- <u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.
- Section 2: That the City Manager is authorized to accept the grant; provided that the City Manager shall have the discretion to refuse the grant in those circumstances where he determines it is in the best interests of the City to do so in which case he shall advise the City Commission of his intention to refuse the funding.
- <u>Section 3</u>: That upon the City Manager accepting said award, the appropriate City officials are authorized to execute all agreements and other applicable documents to facilitate acceptance and implementation of the grant, in a form acceptable to the City Manager and approved as to form by the City Attorney.
- <u>Section 4</u>: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
