CONTRACT NO. DMS-17/18-004B BETWEEN FLORIDA DEPARTMENT OF MANAGEMENT SERVICES AND AT&T ENTERPRISES FLORIDA, LLC

AMENDMENT NO. 3

This Amendment No. 3 ("Amendment") to Contract No. DMS-17/18-004B, SUNCOM Communications Services (the "Contract"), is by and between the State of Florida, Department of Management Services (the "Department"), and AT&T Enterprises Florida, LLC, formerly known as AT&T Corp. (the "Contractor"), collectively referred to herein as the "Parties."

WHEREAS, the Parties entered into the Contract on July 1, 2020; and

WHEREAS, the Parties amended the Contract to renew for five (5) years beginning July 1, 2025, and ending on June 30, 2030; and

WHEREFORE, in consideration of the mutual promises contained below, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties agree to amend the Contract as follows:

1. Contract Section 24. Service Discontinuance and Grandfathering is hereby added to the Contract.

Section 24. Service Discontinuance and Grandfathering

- a. Service is provided subject to availability of suitable facilities and technology. The Contractor will determine the service components, facilities, and technologies that are used to provide service and may make modifications to a service at its option.
- b. Notwithstanding anything to the contrary, the Contractor may discontinue providing a service: (a) upon 12 months' written notice if discontinuing the service to all similarly situated customers in the United States, or (b) a service component upon 120 days' notice. Discontinuance of service in a specific geographic area (e.g., a wire center, city, state or country) is considered discontinuance of a service component and subject to 120 days' notice.
- c. The Contractor may notify the Department that a service or service component is grandfathered. The Department may restrict new site orders and Department move, add, and change orders for a grandfathered service or service components.
- 2. This Amendment is hereby made part of the Contract. Except as otherwise expressly set forth herein, the terms and conditions contained in the Contract shall remain in full force and effect. This Amendment sets forth the understanding between the Parties with regard to the subject matter thereof.
- 3. This Amendment is effective on the last date of execution.
