A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ISSUE THE ATTACHED PURCHASE ORDER BETWEEN RANCO CONSTRUCTION CORP. OF SOUTH FLORIDA AND THE CITY OF HOLLYWOOD FOR THE REPAIR OF AN EXISTING CONCRETE SLAT WALL LOCATED ALONG PEMBROKE ROAD BETWEEN SOUTH 25th AVENUE AND SOUTH 27TH AVENUE IN THE ESTIMATED AMOUNT OF \$69,760.00.

WHEREAS, the Department of Public Works requested that Procurement Services issue a formal solicitation requesting bids from qualified general contractors for the repair of an existing concrete slat wall along Pembroke Road, between South 25th Avenue and South 27th Avenue; and

WHEREAS, although the wall is located on private property, the City Commission finds that repairing the wall will serve a public purpose; and

WHEREAS, the contractor will provide all labor and material to prep, repair and paint, not limited to any necessary fabrication of parts or materials, of the existing concrete slat wall using accepted and approved construction methods; and

WHEREAS, on July 24, 2014, Bid Number F-4430-14-RD was electronically advertised via BidSync; and

WHEREAS, invitations to bid were emailed to one thousand two hundred and fourteen (1,214) registered vendors in BidSync and forty two (42) registered vendors in Bid Sync viewed the bid document; and

WHEREAS, Bid Number F-4430-14-RD opened at 3:00 P.M., August 21, 2014, and resulted in a response from one (1) bidder:

WHEREAS, the Department of Public Works and the Procurement Services Division evaluated the bid submitted for bid requirement compliance and project specifications; and

WHEREAS, after evaluation, the bid submitted by Ranco Construction Corp. of South Florida was determined to be the lowest responsive and responsible bid; and

WHEREAS, Ranco Construction Corp. of South Florida has previously provided similar services to the City, and their performance has been satisfactory; and

WHEREAS, the Director of Public Works and the Director of Procurement Services recommend that the City Commission approve the issuance of the attached purchase order to Ranco Construction Corp. of South Florida of Hollywood, Florida for the repair of an existing concrete slat wall along Pembroke Road, between South 25th Avenue and South 27th Avenue; and

WHEREAS, funding for this project in the amount of \$75,000.00 is available in account number 34.1400.14491.541.006303 and is included in the Adopted Capital Improvement Program for FY2014 as amended via Resolution R-2014-157;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That it hereby approves and authorizes the issuance, by the appropriate City Officials, of the attached Purchase Order between Ranco Construction Corp. of South Florida and the City of Hollywood, together with such non material changes as may be subsequently agreed to by the City Manager and approved as to form and legality by the City Attorney.

Section 2: That this resolution shall be in full force and effect immediately upon its passage and adoption.
