A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, RENAMING OAKWOOD HILLS PARK, LOCATED AT 2701 N 26TH AVENUE, HOLLYWOOD, FLORIDA, AS "HUMANITY PARK".

WHEREAS, Section 155.14(H) of the City of Hollywood Code of Ordinances provides for City Commission approval of the naming and renaming of streets and City facilities, and for the establishment of application fees and procedures by resolution of the City Commission; and

WHEREAS, the City Commission, by Resolution Number R-2005-89 (as amended by R-2012-197 and R-2017-076, R-2022-303), established procedures for the naming and renaming of properties, facilities, parks, and memorials; and

WHEREAS, an application was submitted by The Humanity Project and the LGBTQ+ Council of Hollywood, through representatives Bob Knotts and Lisa Tumminello, seeking to rename Anniversary Park to "Humanity Park"; and

WHEREAS, due to lack of business community support, a new/revised application was submitted by The Humanity Project and the LGBTQ+ Council of Hollywood seeking to rename Oakwood Hills Park to "Humanity Park," which will give the park a more defined purpose of bringing people together in an inclusive and welcoming space representing equality for each and respect for all; and

WHEREAS, the Naming Committee met and reviewed the application and supporting documents, which met all the Naming Policy criteria, and recommends to the City Commission that Oakwood Hills Park be renamed "Humanity Park".

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it renames Oakwood Hills Park, located at 2701 N 26th Avenue, as "Humanity Park".
