Proposal for East Bar Screen Repair and Hydraulic Lift**

Cardinal Contractors, Inc. (PWM) has prepared the following proposal for labor and equipment support during the repair of the East Bar Screen and installation of two new Hydraulic Lifts at Hollywood Headworks.

a. Labor Total	(OH and Profit included on rate)	\$69,406

The pricing is based on the scope discussed and activities as follows:

1. Removal of Huber Machine from Channel
2. Pressure Washing of Equipment
3. Labor and Equipment for lifting Huber Machine and Hydraulic Lifts
4. Including four (4) hours of OT on weekdays and six (6) hours of OT for weekend work.

**Planned Durations**

- Preparation, Removal, and Cleaning of Huber Machine – 3 days
- Assembly of Frame, east bar screen repairs, and reinstallation – 7 days
- Assembly, installation, and testing of new hydraulic lifts – 7 days.

**Qualifications**

- This proposal does not include permitting fees
- This proposal does not include the procurement of parts for East Bar Screening Repair.
- This proposal does not include the procurement of new hydraulic lifts.
- This proposal does not include any prior coordination with Huber during the manufacturing and shipment process of the east bar screening parts and the two new hydraulic lifts.
- This proposal does not include a structural evaluation of the building and its components and is based on the assumption that the current structure can support all new loads. The owner must confirm the existing structure's adequacy before starting work.

- Any additional overtime to what is included in this proposal that is required due to justifiable reasons and is approved by the client will be charged accordingly to OT rates from PWM.
- This proposal does not include services in an operational emergency. Any labor or material required for activities not listed as included in this proposal is additional work and shall be handled through a change order.
- This proposal does not include modifications, improvements, or repairs to the current skylight system.
- Payment Terms: 30 NET after Final Completion.
