Agreement made between Sports Surfaces LLC. hereinafter called the Contractor and The City of Hollywood hereinafter called the Customer for the construction of (2) pickleball courts, install 6' Fence with 1 gate and Court Lighting System with respect to the following terms and specifications:

PICKLEBALL COURTS ASPHALT: (2)

- 1. Court Dimensions: 40' x 120'
 - A. Excavate and remove dirt as necessary
 - B. Install 6" lime rock or shell rock sub base compacted to 4"
 - C. Install 1 1/2" of compacted SIII asphalt.

PICKLEBALL COURT PREPARATION: Area to be approximately: 40' x 120'

The Contractor will pressure clean and power blow court(s) as necessary to remove loose dirt, mildew and oil. The Contractor will patch depressions greater than 1/8" after 1 hour drying time in sunlight, grind down any ridges as

The Contractor shall thoroughly and expediently clean up all drums, trash, etc. upon job completion.

PICKLEBALL COURT FENCING

6 Contractor will install approximately 320' of 6' high green or black fencing with 6'high vinyl coated wire on the pickleball court. Contractor will install (1) pedestrian 4' x 6' gate. Line posts to be 2 ½" OD and Corner posts to be 3" OD. Top rail all 15/8".

LIGHTS

Contractor will install (4) twin Tech-Light lights include 20' pole, ballast, and wiring of poles and installation of light poles on a 3' x 3' concrete footer. Note: price does not include permit costs, running wiring from fuse box to individual poles or upgrades to fuse box

PROVISIONS

The Customer agrees to pay a 33% due upon acceptance of proposal.

The Customer agrees to pay a 33% deposit upon installation of rock.

The Customer agrees to pay balance upon completion of the above-proposed work.

GUARANTEE

The Contractor guarantees all work against defects in workmanship or materials for a **period of (2) years** from date of completion. This guarantee excludes Normal wear and tear, physical abuse or neglect and any other conditions beyond the contractor's control, such as sub-base settling, structural cracks, asphalt shrinkage cracks, hydrostatic pressure or water vapor pressure bubbles, intrusion of weeds or grass, etc. Proper tennis shoes must be worn on court. Some sneakers, street shoes, dark soled shoes, skateboards, roller blades, etc. will scuff and damage surface. Guarantee shall become void upon owner's failure to adhere and comply with the payment schedule.

CREDIT

If the Customer does not pay as agreed upon, the Contractor shall have the right to file a lien against the real estate for the amount of the work done. No further work shall be accomplished if installment payments are not made at the time specified. In the event it is necessary to employ the services of an attorney to secure payment, as per the terms of this agreement, then the customer agrees to pay reasonable attorney fees. Interest of $1\frac{1}{2}$ % per month will be charged on accounts past due

FEE FOR THE CONSTRUCTION OF (2) PICKLEBALL COURTS, LIGHTING AND FENCE

The Contractor agrees to provide tools, materials, labor, supervision and insurance to complete the above work for a sum of
