A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE THE ATTACHED CONTRACT BETWEEN MARVI BUILDERS LLC AND THE CITY OF HOLLYWOOD FOR NEW PILING INSTALLATIONS AT THE HOLLYWOOD MARINA RESTROOM BUILDING, IN THE AMOUNT OF \$75,000.00.

WHEREAS, the Department of Development Services and the Department of Parks, Recreation and Cultural Arts have determined that additional pilings need to be installed to support the concrete stairs and handicapped ramp at the Hollywood Marina Restroom Building ; and

WHEREAS, specifications and details to install the pilings were prepared by a City consultant and the Notice to Bidders was advertised online via BidSync on July 5, 2017; and

WHEREAS, these construction documents and specifications were viewed by thirty-eight (38) vendors on BidSync and five (5) vendors downloaded the Project Manual and specifications; and

WHEREAS, through receipt of the City's bid specifications for this project, all contractors have been provided with a copy of the City's contract, including the terms and conditions contained therein; and

WHEREAS, two (2) bids were received and publicly opened at 10:00 AM on August 2, 2017, and the responsive bids are as follows:

WHEREAS, City staff reviewed the two (2) bids and determined that the bid submitted by Marvi Builders LLC was the overall lowest, responsive and responsible bid, and have recommended the award of the bid to Marvi Builders LLC in the amount not to exceed \$75,000.00; and

WHEREAS, the funding is available in account no. 01.3162.00000.575.005224 and account no. 34.3100.17421.575.006301;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That it hereby approves and authorizes the execution, by the appropriate City Officials, of the attached contract between Marvi Builders LLC, and the City of Hollywood, together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form and legality by the City Attorney.

Section 2: That this resolution shall be in full force and effect immediately upon its passage and adoption.
