Explanation:

The Florida Department of Transportation (FDOT) maintains property for public purposes for the citizens of the State of Florida and is permitted by law to lease rights-of-way to other public entities to further accommodate the public needs of the State of Florida.

A policy change implemented by FDOT has been modified to assess a market value fee for any utilization of FDOT right-of-way that results in a commercial end-use and because of this policy change, FDOT is requiring that both a new lease and an addendum. The addendum includes a modification to design standards, insurance requirements and market valuation for the use of FDOT's rights-of-way.

Annual rent for the first five (5) year terms will be \$3.00 per square foot for each permitted sidewalk café and parking queue on Young Circle, totaling \$10,173.00. This rent will be collected as a part of the sidewalk café and valet permit fee for operation on FDOT right-of-way within the City limits.

The appraisal fee of \$7,950.00 incurred by FDOT will be paid in five annual installments of \$1,590.00.

The total annual cost of \$11,763.00, will be split evenly between the City and the Downtown CRA.

Funding for the City's portion of the annual cost totaling \$5,881.50 will be made available in an account to be established by the Department of Financial Services.
