**Proposed Legislation:**

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE THE ATTACHED AUTHORIZATION TO PROCEED FOR WORK ORDER NO. TTH 17-01 BETWEEN TETRA TECH, INC. AND THE CITY OF HOLLYWOOD TO PROVIDE PROFESSIONAL ENGINEERING SERVICES FOR THE WATER MAIN REPLACEMENT PROGRAM BETWEEN PEMBROKE ROAD AND HOLLYWOOD BOULEVARD FROM SOUTH 56TH AVENUE TO STATE ROAD 7, AS IDENTIFIED IN THE 2007 WATER SYSTEM MASTER PLAN, IN AN AMOUNT NOT TO EXCEED \$730,269.00 (PROJECT NO. 16-5136).

**Explanation:**

The 2007 Water System Master Plan included the need to replace aging water distribution system pipes. This project is currently addressing Professional Engineering Services for water main replacement in the area between Pembroke Road and Hollywood Blvd from 56<sup>th</sup> Avenue to State Road 7.

The City of Hollywood and Tetra Tech, Inc. have a Professional Services Agreement for Engineering Services that was approved through commission action and Resolutions R-2009-214, R-2013-110 and R-2015-068.

The Department of Public Utilities recommends authorizing the ATP with Tetra Tech, Inc. in an amount not to exceed \$730,269 for the professional engineering services for the water main replacement program in the referenced area.

On September 28, 2016 the City Commission approved R-2016-285 which adopted the FY 17 Capital Improvement plan and included funding for the ongoing Water Main Replacement program and those funds are available in account number 42.4000.76663.536.0293121.
