WHEREAS, the CRA and the CONTRACTOR previously entered into a Construction Contract for the Citywide Gateway and Neighborhood Signage Bid No.: RFP-174-24-GJ, dated June 30, 2025 ("Original Agreement"); and

WHEREAS, the CRA and CONTRACTOR agree to enter into this First Amendment to the Original Agreement to amend Exhibit B General Conditions, Article 3.10 Assignment of Contract to allow assignments upon the CRA's sole discretion and written approval.

NOW THEREFORE, in consideration of the promises, mutual covenants, provisions and undertakings contained and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this First Amendment.

2. That the CRA and CONTRACTOR agree to amend Exhibit B General Conditions,

Article 3.10 Assignment of Contract as follows:

underscored are additions.)

3.10 Assignment of Contract:

No assignment by the CONTRACTOR of the Contract or any part thereof, or any monies due or to become due thereunder shall be made: without prior written

consent of the CRA at the CRA's sole discretion.

3. That except as amended herein, the CRA and CONTRACTOR ratify, approve

and reaffirm the terms of the Original Agreement and the Original Agreement shall remain

in full force and effect, except as amended herein. In the event of any conflict or ambiguity

by and between the terms and provisions of the Original Agreement and this First

Amendment, the terms and provisions of this First Amendment shall control to the extent

of any such conflict and ambiguity.
