

ORDINANCE NO. _____

AN ORDINANCE OF THE CITY OF HOLLYWOOD, FLORIDA, AMENDING CHAPTER 103 OF THE CODE OF ORDINANCES ENTITLED "PARKS AND RECREATION"; AUTHORIZING THE CITY MANAGER AND/OR HIS DESIGNEE TO PRODUCE POLICIES AND PROCEDURES FOR THE DEPARTMENT OF PARKS, RECREATION AND CULTURAL ARTS; UPDATING LANGUAGE IN SECTIONS 103.01, 103.02, 103.35; CREATING SECTION 103.13 AUTHORIZING THE CITY MANAGER OR HIS/HER DESIGNEE TO WAIVE APPLICATION FEES AND COSTS; REPEALING SECTIONS 103.15, 103.16, AND 103.32; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Chapter 103 of the Code of Ordinances establishes the schedule of fees and charges for activities such as: youth recreation, adult/senior recreation, Orangebrook Golf Club, facility rental rates and banner permit and installation rates; within the City of Hollywood; and

WHEREAS, in order to best provide service to the community it is necessary to regularly review and amend or update the Code of Ordinances to reflect the changes in the communities needs as well as the marine profession; and

WHEREAS, in the following sections the Director of Parks, Recreation and Cultural Arts and city staff have determined it necessary to further define areas and stream-line processes as noted in the requested changes to Chapter 103 Parks and Recreation; and

WHEREAS, the City Commission finds that these amendments to the Code of Ordinances are in the best interest of the public;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That Chapter 103 of the Code of Ordinances entitled "Parks and Recreation" is hereby amended as follows:

TITLE IX: GENERAL REGULATIONS

CHAPTER 103: PARKS AND RECREATION

GENERAL PROVISIONS

The City Manager and/or his or her designee have the authority to produce policies and procedures for the Department of Parks, Recreation and Cultural Art.

§ 103.01 PUBLIC PARKS MAINTAINED FOR ENJOYMENT OF ALL CITIZENS.

The public parks of the city are held by the city for the use, convenience, and enjoyment of the citizens and inhabitants of the city. None of the city parks shall be used exclusively by any person, or set of persons or association, to the exclusion of the general public, except with the express consent and approval of the City Commission during programming or permitted events and meetings.

§103.02 CLOSING HOURS.

* * *

(B) The Director with approval of the City Manager may, in his or her discretion, change the hours of closing in any park where he or she deems it necessary. The Director with approval of the City Manager shall cause proper notice to be placed in the main entrances to the city parks, playgrounds and properties referred to in division (A), warning the general public that such properties are closed during the hours therein recited.

§ 103.13 WAIVER OF FINANCIAL ACCOUNTABILITY REQUIREMENTS.

For non-profit, charitable or civic organizations residing within Broward County and/or which offer a defined benefit to the local community, the City Manager or his/her designee may approve a waiver of all or a portion of the application fee, or associated costs as appears in the Parks, Recreation and Cultural Arts Schedule of Fees and Charges, approved by resolution of the City Commission.

Section 2: That it is the intention of the City Commission and it is hereby ordained that the provisions of this ordinance shall be made a part of the Code of Ordinances of the City of Hollywood, Florida, and the sections of this Code may be renumbered to accomplish such intention.

Section 3: That if any word, phrase, clause, subsection or section of this ordinance is for any reason held unconstitutional or invalid, the invalidity thereof shall not affect the validity of any remaining portions of this ordinance.

Section 4: That all sections or parts of sections of the Code of Ordinances, all ordinances or parts of ordinances, and all resolutions or parts of resolutions in conflict herewith be and the same are hereby repealed to the extent of such conflict.

Section 5: That this Ordinance shall be in full force and effect immediately upon its passage and adoption.
