WHEREAS, Section 2.04 of the City's Charter provides, in relevant part, that the City Commission shall schedule no fewer than 20 regular meetings per year and shall hold no fewer than 18 regular meetings per year at such times and places as shall be specified by resolution; and

WHEREAS, Section 2.04(c)(f) of the City's Charter provides, that Citizens' Comments shall be held during every regularly scheduled City Commission meeting; and

WHEREAS, pursuant to a series of resolutions, the City Commission has adopted its regular meeting schedule as the first and third Wednesdays of each month starting at 1:00 P.M., except during the month of August; and

WHEREAS, due to Broward County Public Schools Spring Break holiday, the City Commission desires to change the regularly scheduled Wednesday, March 18, 2026, meeting to Wednesday, March 25, 2026; and

WHEREAS, due to Passover, the City Commission desires to change the regularly scheduled Wednesday, April 1, 2026, meeting to Monday, April 6, 2026; and

WHEREAS, in order to allow more time to receive the July Taxable Value Report for purposes of setting the maximum millage and the Fourth of July holiday, the City Commission desires to change the regularly scheduled Wednesday, July 1, 2026, meeting to Tuesday, July 7, 2026; and

WHEREAS, in order to allow more time for next fiscal year's budget preparation, the City Commission desires to change the regularly scheduled Wednesday, July 15, 2026, meeting to Wednesday, August 26, 2026; and

WHEREAS, due to the Election Day on Tuesday, November 3, 2026, the City Commission desires to change the regularly scheduled Wednesday, November 4, 2026, meeting to Thursday, November 5, 2026; and

- WHEREAS, due to the Swearing-In Ceremony, the City Commission desires to change the regularly scheduled Wednesday, November 18, 2026, meeting to Monday, November 30, 2026, starting at 11:00 A.M.; and
- WHEREAS, due to the proximity to the Thanksgiving holiday, the City Commission desires to change the regularly scheduled Wednesday, December 2, 2026, meeting to Wednesday, December 9, 2026; and
- WHEREAS, the City Commission desires to cancel the regularly scheduled Wednesday, December 16, 2026, meeting due to the holidays; and
- WHEREAS, the City Commission desires to cancel the regularly scheduled Wednesday, January 6, 2027, meeting due to the holidays.
- NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:
- <u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.
- <u>Section 1</u>: That the regular meeting of the City Commission scheduled on Wednesday, March 18, 2026, shall be rescheduled in the City Commission Chambers at City Hall, 2600 Hollywood Boulevard, to Wednesday, March 25, 2026.
- <u>Section 2</u>: That the regular meeting of the City Commission scheduled on Wednesday, April 1, 2026, shall be rescheduled in the City Commission Chambers at City Hall, 2600 Hollywood Boulevard, to Monday, April 6, 2026.
- <u>Section 3</u>: That the regular meeting of the City Commission scheduled on Wednesday, July 1, 2026, shall be rescheduled in the City Commission Chambers at City Hall, 2600 Hollywood Boulevard, to Tuesday, July 7, 2026.
- <u>Section 4</u>: That the regular meeting of the City Commission scheduled on Wednesday, July 15, 2026, shall be rescheduled in the City Commission Chambers at City Hall, 2600 Hollywood Boulevard, to Wednesday, August 26, 2026.
- <u>Section 5</u>: That the regular meeting of the City Commission scheduled on Wednesday, November 4, 2026, shall be rescheduled in the City Commission Chambers at City Hall, 2600 Hollywood Boulevard, to Thursday, November 5, 2026.
- <u>Section 6</u>: That the regular meeting of the City Commission scheduled on Wednesday, November 18, 2026, shall be rescheduled in the City Commission Chambers at City Hall, 2600 Hollywood Boulevard, to Monday, November 30, 2026, starting at 11:00 A.M.

Section 7: That the regular meeting of the City Commission scheduled on Wednesday, December 2, 2026, shall be rescheduled in the City Commission Chambers at City Hall, 2600 Hollywood Boulevard, to Wednesday, December 9, 2026.
Section 8: That the regular meeting of the City Commission scheduled on Wednesday, December 16, 2026, shall be cancelled.
Section 9: That the regular meeting of the City Commission scheduled on Wednesday, January 6, 2027, shall be cancelled.
Section 10: Thereafter, regular meetings of the City Commission shall, unless otherwise provided by resolution, be held on the first and third Wednesdays of each month.
Section 11: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
