## RESOLUTION NO. R-CRA-

A RESOLUTION OF THE HOLLYWOOD, FLORIDA COMMUNITY REDEVELOPMENT AGENCY ("CRA"), APPROVING AUTHORIZING THE APPROPRIATE CRA OFFICIALS TO EXECUTE A PROPERTY IMPROVEMENT PROGRAM GRANT AGREEMENT WITH BATWANG LLC FOR **ON-SITE** IMPROVEMENTS TO THE PROPERTY LOCATED AT 1940 & 1942 HOLLYWOOD BOULEVARD IN A TOTAL GRANT AMOUNT UP TO \$150,000.00.

WHEREAS, on February 2, 2011, the Community Redevelopment Agency ("CRA") Board passed and adopted Resolution No. R-CRA-2011-08, which amended and consolidated the Property Improvement Program ("PIP") for the Beach and Downtown Districts into one comprehensive program; and

WHEREAS, the CRA adopted the PIP to facilitate the upgrading of structures and/or eliminate slum and blighting influences within both districts of the CRA; and

WHEREAS, the PIP is a comprehensive program with eligibility guidelines and specific criteria; and

WHEREAS, Barrett Windish, as a duly authorized representative of Batwang LLC, ("Batwang"), submitted an application in accordance with the PIP requirements; and

WHEREAS, Batwang intends to improve the appearance of the property located at 1940 & 1942 Hollywood Boulevard, which is within the Downtown District of the CRA; and

WHEREAS, CRA staff has reviewed the application in accordance with the PIP guidelines and has determined that Batwang's application meets the eligibility criteria for a grant under the PIP; and

WHEREAS, the total project cost for the 1940 & 1942 Hollywood Boulevard building is estimated at \$457,980.00, and the grant amount for this project will not exceed \$150,000.00, making the CRA's contribution approximately 32% of the total cost; and

WHEREAS, Batwang will expend these monies on the project and the grant funds will be distributed upon completion of improvements; and

WHEREAS, the proposed private redevelopment will enhance and preserve the CRA redevelopment efforts in the area and further promote commercial redevelopment in the CRA District; and

WHEREAS, the CRA Executive Director and CRA staff recommend approval of a grant to Batwang pursuant to the PIP; and

WHEREAS, after reviewing the applications submitted by Barrett Windish on behalf of Batwang, the CRA Board has found and determined that it would be beneficial to the redevelopment effort and a proper public purpose under Chapter 163, Florida Statutes, to support Batwang's improvement project through a grant of funds pursuant to the terms and conditions set forth in the attached PIP Grant Agreement to be executed by the parties; and

WHEREAS, funding for the attached PIP Grant Agreement have been appropriated and exists in account number Downtown CRA - 166.668602.55200.548640.000000.000.000

NOW, THEREFORE, BE IT RESOLVED BY THE HOLLYWOOD, FLORIDA COMMUNITY REDEVELOPMENT AGENCY:

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and authorizes the execution, by the appropriate CRA officials, of the attached PIP Grant Agreement with Batwang, located at 1940 & 1942 Hollywood Boulevard, together with such non-material changes as may subsequently be agreed to by the CRA Executive Director and approved as to form by the CRA's Interim General Counsel.

<u>Section 3</u>: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
