A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ISSUE A PURCHASE ORDER TO FISHER SCIENTIFIC COMPANY, LLC FOR THE PURCHASE OF AN MX908 PORTABLE MASS SPECTROMETER IN THE APPROXIMATE AMOUNT OF \$73,500.00 (PIGGYBACK).

WHEREAS, the Police Department has been authorized as a sub-grantee to receive State of Florida, Department of Health, Broward County Health Department sub-grant funds in the approximate amount of \$73,500.00; and

WHEREAS, the sub-grant funds will be used to purchase an MX908 portable mass spectrometer to improve opioid drug surveillance; and

WHEREAS, the requested product is available from Fisher Scientific Company, LLC via the General Services Administration ("GSA") Contract Number GS-07F-100GA, which was competitively bid, and Fisher Scientific Company, LLC has agreed to provide the City the same pricing terms and conditions as listed on the GSA contract; and

WHEREAS, Section 38.41(C)(5) of the Purchasing Ordinance allows the Chief Procurement Officer to procure, without following formal procedures, all goods and services that are subject of contracts with the State, its political subdivisions, the United States government, other governmental entities, or a corporation not for profit whose members are governmental entities, public officers, or any combination thereof, provided that the goods and services are (i) the subject of a price schedule negotiated by the State or the United States government, or (ii) the subject of a contract with another governmental entity or a corporation not for profit whose members are governmental entities, public officers, or any combination thereof, which contract is based strictly on competitive bids or competitive proposals and not on any preference; and

WHEREAS, this purchase is contingent upon the approval and acceptance of the State of Florida, Department of Health, Broward Health Department grant funds Resolution; and

WHEREAS, the Chief of Police recommends that the City Commission approve the issuance of a purchase order to Fisher Scientific Company, LLC for the purchase of an MX908 portable mass spectrometer in the approximate amount of \$73,500.00; and

WHEREAS, funding in the amount of \$73,500.00 will be made available in account number to be determined subject to adoption of a companion budget amendment resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and authorizes the issuance, by the appropriate City officials, of a purchase order to Fisher Scientific Company, LLC, together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 3: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
