Organization’s Background: Please provide a concise description of the Applicant Agency, including its history, years of operation, general mission statement, and primary services provided.

The Art and Culture Center/Hollywood is the third oldest arts non-profit in Broward County and one of South Florida’s leading multi-disciplinary arts organizations for its contemporary gallery exhibitions, arts education for youth, and award-winning documentary film shorts. Our mission is to cultivate creativity and the support of the arts in our community through education, innovation, and collaboration. The Center was founded on Aug. 31, 1975, as the only visual arts non-profit organization in south Broward County, operating out of a small community space on Hollywood beach. We now manage visual arts galleries in the renovated Kagey Home built in 1924, an Arts School that is adjacent to the main facility, and the 500-seat Hollywood Central Performing Arts Center located near downtown Hollywood. In 2019, the Center was allocated \$2.5 million in City funds towards its Arts Ignite! building initiative as part of a General Obligation Bond (GO Bond) referendum that was approved by Hollywood voters. These funds will support the expansion of our facilities through a new 5,000-square-foot Arts Education Wing that will adjoin the current gallery/administrative offices. The new wing will provide visual arts and multimedia studio classrooms, along with a multi-purpose room for dance, drama, artist talks, film screenings, meeting space and more. Additionally, the new education building incorporates an outdoor courtyard to enhance the visitor experience. The dramatic design will merge with the existing two-story, 1924 Mediterranean Revival architecture of the Kagey Home, which houses the Center galleries and administrative offices. With a targeted opening in the fall 2024, the new wing, with its gleaming façade and swooping rooftop, will provide the Center and the City with a unique architectural distinction in Broward County of having adjoining, functional spaces built 100 years apart.

In 2002-03, the Center created a formal, year-round structure for its arts education programming for youth that has since expanded to 10 unique programs. In FY22, more than 9,000 youth experienced the arts in more than 150 unique curriculum sessions or classes, or as attendees to a Center performance or exhibition. We make arts education programming accessible to all populations through free programs such as Arts Aspire, Free Arts! Family Days, and Distance Learning arts instruction presented to Broward County K-12 schools; and by offering reduced-tuition scholarships for Summer Arts Camp and our after-school programs. About 200+ youth ages 5-16 enroll each summer in a visual and/or performing arts session at Summer Arts Camp. Instruction for youth links curricula to other core subjects such as math, science, literacy, and cultural studies. This shows students how the arts may inform all facets of learning. In 2016, the Center received an ArtsEd Forever! award from the Broward Cultural Division for Exceptional Service & Outstanding Contributions to Arts Education in Broward County. The Center presents originally curated contemporary gallery exhibitions in four distinct gallery spaces that showcase works by about 125 artists annually. Exhibitions feature artist receptions, interactive art-making for families, and artist/curator talks. Our monthly Free Arts! Family Days provides free admission and a thematic art-making activity on the third Sunday of every month. The Center’s *Open Dialogues* films foster community engagement through public screenings and moderated discussions. Center programs attract residents from throughout South Florida and visitors to our region, raising awareness of Hollywood as a leading arts destination while providing economic benefits to City businesses.

PROGRAM INFORMATION

1. How does your proposed project address the LETF Category (see above) as well as the Hollywood Police Department's Priority Area?

The Arts Access Leadership and Scholarship Program will provide youth from all economic backgrounds in Hollywood with intensive development opportunities in FY24 through two arts-education initiatives – the Arts Aspire leadership program (Oct. 2023 to Aug. 2024) and reduced-tuition scholarships for students ages 5-16 enrolled in our FY24 fee-based after-school programs (Oct.-May) and the 2024 Summer Arts Camp (June-Aug.). Arts Access provides youth with focused and collaborative activities that are presented in a safe, nurturing environment outside of school sites, assuring continued academic and personal growth in after-school and summer-break settings. The benefits of arts education can be especially profound for children from low-income households, such as those who receive reduced-tuition scholarships to develop their skills and creativity, or receive worksite and leadership experiences through Arts Aspire.

In a study published by the American Psychological Association in 2020, researchers found, “Children with stronger school readiness skills at age 4 and stronger academics in 5th grade were more likely to enroll in arts-related courses,” and that “students with exposure to an arts elective in middle school subsequently had significantly higher GPAs and math and reading scores, and decreased odds of school suspension, compared to students not exposed to the arts” (*Psychology of Aesthetics, Creativity, and the Arts*). According to a report from Fight Crime: Invest in Kids, a nonprofit anti-crime organization comprised of more than 3,000 police chiefs, sheriffs, prosecutors, and other law enforcement leaders, school dropouts are 3.5 times more likely to be arrested than high school graduates and more than eight times as likely to be incarcerated. Further research shows high-school students who earned few or no arts credits were five times more likely not to have graduated than students who earned many arts credits (2008-09 National Longitudinal Survey of Youth of 1997 (NLSY97); U.S. Department of Labor). According to researchers at the Harvard University Graduate School of Education, children growing up in economically disadvantaged environments may be at risk for academic difficulties related to vocabulary acquisition because they are exposed to less verbal input. One parent shared how the Center's Summer Arts Camp impacted her daughter: “The ability for effective verbal communication is more important than ever and I know that [my daughter's] abilities in this arena have been significantly enhanced thanks to your summer camp.” Through Arts Access education programs that serve Hollywood youth and families, the Center sees first-hand how youth develop the social and leadership skills that divert them and their peer group from harmful activities that can have a negative impact on their lives.

2. Why is this funding needed (What community problem does it address)? What data suggests this program should be implemented with this population or in this geographical location?

The U.S. Dept. of Justice, Office of Juvenile Justice and Delinquency Prevention encourages children to use their creative talents because, “arts and performances help youth develop a sense of identity, independence, discipline, and self-worth. They also help prevent or reduce crime and violence among the young artists and performers involved. According to research, students who participate in band, orchestra, chorus, or drama are significantly less likely than non-participants to drop out of school, be arrested, use drugs, or engage in binge drinking.” The need for free/reduced-tuition out-of-school arts programming for children from low-income homes is great in Hollywood, where 19 of the 20 public schools are Title I schools. Also, according to the U.S. Census Bureau's American Community Survey, the median household income in Hollywood from 2017-2021 was \$56,912, which is 12% less than the median income in Broward County (\$64,522).

3. Program Summary (3-5 sentences): Provide an overview of program services.

The Art and Culture Center/Hollywood requests funding from the Hollywood Police Dept. LETF to support two Arts Access program initiatives that will serve Hollywood youth in 2023-24: the leadership and worksite development program Arts Aspire, and reduced-tuition scholarships for children from qualifying low-income families who wish to enroll in after-school and Summer Arts Camp programs. At a time when youth are in need of supportive creative spaces following the social isolation caused by Covid-19, Arts Access program activities will provide youth of all backgrounds in Hollywood with structured and fully interactive arts-learning experiences outside their K-12 school setting. Information about Arts Aspire and reduced-tuition scholarships will be posted at the Center's website and in the 2024 Summer Arts Camp marketing materials. LETF funding from the Hollywood Police Department would also support staff costs to supervise and mentor approximately 30 Hollywood residents who will participate in more than 2,500 hours of Arts Access activities. Applications for reduced-tuition scholarships are awarded on a first-come, first-serve basis contingent on available funds.

4. Describe the program in detail and how it will be implemented: (Describe Who, What, Where, and When)

Arts Access Leadership and Scholarship programming will be presented in two distinct program periods in FY24: a school-calendar session for Arts Aspire and after-school program sessions (Oct. 1-May 31) and the nine-week Summer Arts Camp (June 10-Aug. 17, 2024). Arts Aspire will be offered during each session with a focus on the Arts Ambassadors tier designed for high-school students ages 14-18. Arts Ambassadors is the first tier in Arts Aspire development pyramid, which provides additional opportunities for utilizing leadership and workplace skills, with paid stipends at the Arts Apprentice (18-25) level.

Ambassadors in Arts Aspire will receive on-the-job training working as volunteers at Center events, as well as participating in activities that build life and technical skills. In many cases, these students have participated previously in the Center's out-of-school visual and performing arts programs, such as Summer Arts Camp, and retain an interest in developing administrative and program delivery skills in the arts. Ambassadors attend one mandatory meeting each month that focuses on presentations from Center staff and educators. In addition, Ambassadors take part in collaborative skills-building activities that require teamwork and foster camaraderie. Opportunities to volunteer at Center events, such as gallery receptions, our monthly Free Arts! Family Days program, Community Gallery exhibitions, and off-site events such as Tri-Rail Fun Day, will be available during the school-year calendar. Arts Ambassadors under Arts Aspire earn Community Service hours that are a requirement toward receiving their high-school diploma, as well as benefiting from Bright Futures scholarships to attend college, should they qualify.

LETF funds will also support reduced-tuition scholarships during the school-year programs ARTastic Artists (ages 6-10), Stage Kids (8-13) and ENCORE (13-16), and the 2024 Summer Arts Camp. After-school programs meet for eight or 12 weeks in fall and winter/spring sessions, concluding with an exhibition or performance. The Center projects that 250 youth will enroll in Summer Arts Camp and after-school programs in FY24, with about 65% of student enrollments being Hollywood residents. LETF funds will support up to 12 scholarship awards to Hollywood youth ages 5-16 from qualifying households. Programming is presented at the Art and Culture Center/Hollywood's Arts School, 1626 Harrison Street; the Center's Community Gallery, 1650 Harrison Street; Hollywood Central Performing Arts Center, 1770 Monroe Street; and ArtsPark at Young Circle.

Summer Arts Camp consists of full- and half-day sessions for ages 5-16, 2-to-4 weeks in length, in the visual and/or performing arts. Camp programs will be offered as follows in 2024:

- a. Artistic Adventurers: Four two-week program periods (8 sessions total based on separate half-day sessions for mornings and afternoons) for ages 5-7. Children may enroll for one or both sessions.
- b. Young Actors + Young Artists: Four two-week program periods (eight sessions total based on half-day sessions for Actors and Artists) for ages 8-10. Children may enroll for one or both sessions.
- c. Broadway Actors: Two 4-week, full-day sessions (ages 9-16), concluding with performances of a Broadway, Jr. musical. Session 1: June 17-July 13; and Session 2: July 22-August 17, 2024.

All camp sessions meet daily, Monday through Friday, reducing the amount of idle time that can result in wayward choices. Each session concludes with campers presenting an exhibition or a performance at their camp location or the 500-seat Hollywood Central Performing Arts Center. Youth and their caregivers are informed at the outset that the camp mandates attendance levels leading up to their final performing-arts presentation. This instills a sense of personal responsibility and team building that are essential in their personal and academic development. "This camp introduces the attendees to experiences they would not have if they had not attended," wrote one parent in a program survey. "To be able to have fun at camp while building self-esteem, learning important life skills, and exercising the brain is priceless! Although the camp is worth every penny, if it were not for the tuition waiver discount, my son could not attend. THANK YOU for the financial assistance!"

Tuition scholarships are available to children from families who qualify for the federal free/reduced school lunch program. Family income must be at or below the following Florida income guidelines set in FY22: \$33,874 for a family of two; \$42,606 (family of three); \$51,338 (family of four). According to Broward County Public Schools, more than 70% of the K-12 students enrolled in 20 public schools in Hollywood participate in this program each year. Summer Arts Camp and after-school programs are open to all youth, regardless of ability level or socioeconomic status. Applications for reduced-tuition scholarships are available to families who contact the Center's Education Dept. to complete an application, and they are awarded on a first-come, first-serve basis, based on available funds. Since 2009, the Center has awarded more than \$118,000 in tuition funds to 389 youth, the vast majority from Hollywood.

The primary goal of all education programs is to provide youth, including those who have little or no experience in the arts, with a structured and fully interactive arts learning environment. Research shows that children who participate regularly in the arts improve their attention span, learn more quickly, and develop higher level critical thinking skills that lead to positive social outcomes. For each of our education program sessions, the Center contracts with professional teachers/artists to create curriculum materials. Teachers/artists are assisted by up to 20 high-school and college-age students in Arts Aspire, of which, as many as 15 will be Arts Ambassadors. Arts Aspire students provide 2,500+ volunteer and paid worksite hours during Summer Arts Camp. For paid positions at the Art Apprentice tier, Center staff designs activities in their departmental area. Candidates are recruited through area colleges and universities. Opportunities are also provided to those on a vocational track that is targeted to the arts, such as sound or lighting tech. The nonprofit arts-and-culture sector is a \$400-million industry that supports 11,000+ full-time equivalent jobs in Broward County (Arts & Economic Prosperity 5 report; Americans for the Arts).

5. Describe the Applicant Agency's experience in serving the target population and the capacity of the Applicant Agency to undertake the proposed program.

The target population is families with children ages 5-16 who are at various stages in their development in terms of how they make decisions that result in positive outcomes. While other organizations provide arts activities outside school facilities, the Center's Arts Aspire development program and education programs are the most comprehensive and impactful programs of their kind for youth in south Broward County and northeast Miami-Dade. The Center is unique in providing financial aid to its school-year and summer-camp programs through reduced-tuition scholarships. Director of Education Amanda Smith oversees all arts education programming at the Center. She has more than 20 years of experience in the field of arts and science education. Before joining the Center in 2019, she worked at the Brooklyn Children's Museum, Cleveland Museum of Art, Museum of Contemporary Art Chicago, and Chicago Academy of Sciences / Peggy Notebaert Nature Museum.

Instructors contracted by the Center encourage good decision-making through activities that require teamwork, creative problem solving, respect for others, accepting responsibility, and following through. Children develop self-confidence and improve their communication skills in a safe, healthy and nurturing environment under the guidance of strong adult role models. This provides the foundation for a safer community by helping children experience success and avoid destructive behaviors that lead to drug use and criminal activity. LETF Funds will support, in part, reduced-tuition scholarships that are available to children from families who qualify for the federal free/reduced school lunch program, thus taking them off the streets and giving them a positive, high-quality experience during the summer. Approximately 65% of summer camp enrollments live in Hollywood.

6. Has your agency received funding from LETF? (If yes, identify the source, the \$ amount and provide performance data regarding your contracted outcomes for the various fiscal years your agency was funded).

The Center received a \$10,000 LETF grant for the Arts Access Leadership and Scholarship Program for FY22 and FY23. To date in FY23 (Oct. 2022 to April 2023), nine Ambassadors and two paid Apprentices have received 350+ hours of worksite and leadership development under the mentorship of Center staff during the school-calendar session. In addition to monthly meetings, Ambassadors have received volunteer experience assisting staff with our monthly Free Arts! Family Days and Stage Kids after-school program, and the off-site events My Hollywood Pride street fair and Tri-Rail Fun Day. Apprentice interns have worked nearly 200 hours under the direct supervision of the Curator of Exhibitions Meaghan Kent and Design and Web Manager Yvette Wasserman. Interns were given work assignments and mentored at each stage of completing a task. Program activities will be amended beginning in June with the start of Summer Arts Camp and the gallery exhibitions *Abstracted* and *Love the Everglades Movement*.

The Center received grants from Hollywood Police Department's Law Enforcement Trust Fund for reduced-tuition scholarships for Hollywood residents from 2015-2017, 2019 and 2021 Summer Arts Camps, helping support reduced-tuition funds for more than 80 Hollywood youth and families. LETF funds also helped underwrite costs for instructor positions and supplies for performances or exhibitions created by more than 1,050 youth during those five summer camps.

BUDGET NARRATIVE (Required for ALL applications)(Provide an explanation of what the budget will include)

The LETF request supports a portion of the costs to underwrite reduced-tuition scholarships for approximately 12 youth from Hollywood, and for costs associated with Education Staff program positions, outside teachers/artists, and supplies to present Arts Access Leadership and Scholarship activities. Personnel Costs/Salaries represent full-time positions for the Director of Education and two Education Coordinators to design and implement Arts Aspire, after-school, and daily Summer Arts Camp activities from Oct. 1, 2023 to Aug. 31, 2024; and activities for the Technical Director and Theater Director at the Hollywood Central Performing Arts Center. Additional administrative and programmatic staff positions are for Executive Director to oversee program activities; Design and Web Manager to create print and online marketing materials; Partnerships and Communications Director to coordinate advertising/marketing outreach; Director of Development to write grants and reports for funders; Finance Manager (accounting); and Custodian. The Director of Education supervises Arts Aspire, after-school programs, and Summer Arts Camp with support from the Education Coordinators who work directly with teachers/artists and students, and communicate with families.

Consultants and Professional Fees (\$39,600) is for contract labor for about 32 outside teacher/artist positions required to deliver program sessions during Summer Arts Camp. Supplies (\$5,800) include art supplies for Arts Aspire and summer camp activities; the rights fees for the scripts to present two Junior theatrical productions; and performance materials for visual pieces and live theatrical productions. Printing and Copying (\$1,000) represents the costs to print Arts Aspire and Summer Arts Camp marketing materials, and for event programs for exhibitions and performances that close each camp session. Postage (\$500) is the cost to mail a portion of the summer camp postcards to families on the Center’s mailing list. Advertising (\$2,000) includes ads that reach families with school-age children. Insurance (\$990) is for supplemental insurance for camp participants.

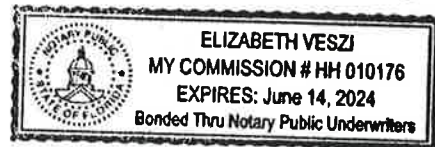

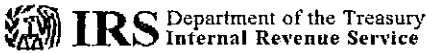

Specifically, section 6033(j) of the Code provides that failure to file an annual information return for three consecutive years results in revocation of tax-exempt status as of the filing due date of the third return for organizations required to file. We will publish a list of organizations whose tax-exempt status was revoked under section 6033(j) of the Code on our website beginning in early 2011.
