A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING APPROPRIATE CITY OFFICIALS TO ISSUE A BLANKET PURCHASE ORDER WITH BEACH RAKER, LLC. FOR BEACH CLEANUP FOR AN ANNUAL AMOUNT NOT TO EXCEED \$338,750.00 BASED UPON THE CITY'S BID NO. F-4614-19-PB.

WHEREAS, seaweed accumulation along Hollywood Beach has been unparalleled, and the Director of Public Works along with the Director of Procurement and Contract Compliance concur that the excessive seaweed accumulation has impacted not only City operations, but the preservation and protection of property, the health or safety of the public, and the economic driver of business and tourism on the beach; and

WHEREAS, Solicitation Number F-4614-19-PB, Beach Cleanup, was posted in BidSync on May 14, 2019, and closed on June 6, 2019; and

WHEREAS, the following two bids were received:

Beach Raker, LLC.	Pompano Beach, FL	\$338,750.00
Lil Mo Marine	Service Cape Coral, FL	\$366,287.50; and

WHEREAS, the Department of Public Works and the Office of Procurement Services concurred that Beach Raker, LLC. is the lowest responsive, responsible bidder; and

WHEREAS, it is the recommendation of the Director of Public Work and the Director of Procurement and Contract Compliance to award a contract to Beach Raker, LLC. for an initial three year term with one additional two year optional renewal; and

WHEREAS, funding has been provided in the fiscal year 2020 budget, to be shared equally by the Public Works Beach Maintenance Division and the Community Redevelopment Agency (CRA) - Small Capital Improvement Account Numbers 001.500204.51900.531170.000000.000.000 and 163.639901.55200.552240.000015.000.000.
