A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO RENEW THE EXISTING PROFESSIONAL SERVICES AGREEMENTS TO PROVIDE ARCHITECTURAL DESIGN SERVICES WITH BERMELLO AJAMIL & PARTNERS, INC., SYNALOVSKI ROMANIK SAYE, LLC, AND SALTZ MICHELSON ARCHITECTS, INC. FOR A ONE YEAR PERIOD, UNDER THE SAME TERMS AND CONDITIONS.

WHEREAS, on February 18, 2015, the City Commission passed and adopted Resolution No. R-2015-042, which authorized City officials to negotiate and execute continuing agreements on a rotating basis with the three highest ranked firms, Bermello Ajamil & Partners, Inc., Synalovski Romanik Saye LLC, and Saltz Michelson Architects, Inc.; and

WHEREAS, the negotiated agreements were for an initial three year term and contained the right to renew for two subsequent one year terms based on satisfactory performance and mutual agreement; and

WHEREAS, the initial agreement with Saltz Michelson Architects will expire on March 25, 2018; and

WHEREAS, the initial agreement with Bermello Ajamil & Partners, Inc. will expire on April 27, 2018; and

WHEREAS, the initial agreement with Synalovski Romanik Saye, LLC will expire on April 13, 2018; and

WHEREAS, the City staff has reviewed the past performance of the firms and found the performance of all three firms to have been satisfactory; and

WHEREAS, City staff desires to renew the agreements with all three firms, and each firm has agreed to renew its agreements for the first one year renewal term under the same terms and conditions; and

WHEREAS, the cumulative amount of fees to be paid for services provided by each consultant under each continuing contract shall not exceed \$1,000,000.00, and sufficient funding will be provided in each of the individual capital project budgets to include the costs of said structural engineering services and other related professional and/or engineering services costs, all construction costs and all other ancillary, related

capital project costs, subject to the review and approval of the City Commission of each individual capital project prior to the commencement of each capital project when scheduled; and

WHEREAS, it is recommended that the City Commission approve the renewal of the Professional Services Agreements for Architectural Design Services under the same terms and conditions with each of the aforementioned firms for a one year term, subject to the City's receipt of a current Certificate of Insurance required by the City's Risk Manager.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it authorizes the appropriate City officials to renew the Professional Services Agreement for Architectural Design Services with Bermello Ajamil & Partners, Inc., for the first one year renewal term under the same terms and conditions.

Section 3: That it authorizes the appropriate City officials to renew the Professional Services Agreement for Architectural Design Services with Synalovski Romanik Saye LLC., for the first one year renewal term under the same terms and conditions.

Section 4: That it authorizes the appropriate City officials to renew the Professional Services Agreement for Architectural Design Services with Saltz Michelson Architects, Inc., for the first one year renewal term under the same terms and conditions.

Section 5: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
