SUBJECT: Recommendation to Approve the Issuance of a Purchase Order to Lanzo

Construction Company for the Emergency Repair of the 72-Inch Grit Chamber Effluent Pipe in an Amount up to \$425,580.00. The Procurement Method used is

City Manager's approval is required to implement an emergency repair of the 72-inch pipe between the Grit Chambers and Influent Pump Station at the Southern Regional Wastewater Treatment Plant ("SRWWTP").

EXPLANATION:

A progressive collapse in the asphalt pavement was observed between Grit Chambers and Influent Pump Station at SRWWTP on Monday, April 17, 2023. The Department initiated an emergency response to this incident, including the following tasks:

- Department staff safeguarded the sinkhole and the surrounding area.
- On April 18, 2023, the Department arranged CCTV inspection of this pipe. A hole, approximately 12-inches in diameter was identified in the crown of the pipe.

• On April 20, 2023, Hazen and Sawyer, P.C. ("H&S"), consultant for the SRWWTP, completed a preliminary evaluation based on CCTV findings and recommended additional inspections by a diver to determine the best repair method.

- On April 26, 2023, a diver completed an inspection of the 72-inch Grit Chamber Effluent Pipe and the Influent Pump Station wetwell.
- On May 2, 2023, H&S recommended that City initiate an emergency repair with either cured-in-place pipe lining or slip-lining techniques, based on extensive loss of pipe material and potential imminent pipe collapse caused by heavy groundwater ingress. H&S also confirmed that Lanzo Construction Company and Insituform Technologies, LLC are the only two contractors qualified to repair this pipe size with the recommended method in South Florida.
- On May 4, 2023, Department staff met with Lanzo Construction Company and clarified construction details and products to be utilized for the repair.
- Department staff met with Insituform Technologies, LLC on April 24, 2023, on-site, and requested a proposal several times after the meeting.
- On May 10, 2023, the Department received only one bid as listed below:

Contractor did not respond.

ESSD staff concluded that awarding the repair to the Lanzo Construction Company is in the best interest of the City.

72-in Grit Chamber Effluent Pipe Failure

Introduction

This memorandum describes the severely deteriorated condition of the 72-inch grit chamber effluent pipe and presents preliminary recommendations concerning repair options. This pipeline, installed in 1968 and about 30 feet in length, transmits the entirety of screened, de-gritted effluent to influent pump station for distribution and treatment.

Pipe Condition

The City was first alerted to a potential problem in the pipe due to surface settlement including a progressive collapse in the asphalt pavement and the gradual sinking of an adjacent light pole (see

photograph at right). Initial inspection of the pipe revealed a hole in the pipe crown with an extremely heavy ingress of groundwater infiltration. The pipe crown is approximately 17 feet below grade and approximately 10-12 feet below the groundwater table. Surface settlement indicates that significant soil loss has occurred above the pipe as infiltration carries the overlying soil into the pipe.

Pipe condition was confirmed via diver inspection conducted on April 26, 2023. Several areas of marked deterioration were noted along the interior of the pipe crown. The most serious of these is a large section of severely deteriorated pipe associated with the heavy infiltration mentioned above. The deteriorated section features a major loss of pipe wall and appears to present a risk of imminent collapse (photograph on following page).



Repair Alternatives

Conditions indicate that the City's interests would be best served through an expedited intervention to perform a repair prior to collapse. In the event that a full pipe collapse occurs, other options will no longer




be feasible and excavation will be required. Due to operational considerations, and to complications associated with the depth of the pipe and the nature of the adjacent structures, excavation is seen to be the most disruptive and expensive repair option and thereby something to be avoided if possible.

Two alternatives are currently under consideration for a near-term repair intervention:

• Cured-in-place pipe lining: This option involves the installation and "curing" of a resin-impregnated, fiberglass-reinforced felt liner. Once the resin is cured it achieves high structural strength as well as chemical resistance to common sewage components. The liner is designed to provide a fully structural

solution with no reliance on

the original pipe.



process features insertion of a fully structural pipe with an exterior diameter slightly smaller than the interior diameter of the original pipe. The remaining space (annular space) is typically filled with a cementitious grout. Various pipe materials can be used for slip-lining pipe.

Access and cleaning requirements for both options are similar. Some loss of internal diameter will also apply to both options, although due to the relatively short (approximately 30 linear feet) length of the pipe this is not expected to represent a significant concern.

In contrast to slip-lining, cured-in-place lining requires a mostly dry pipe, and accordingly prerequisite tasks would also include (a) chemical grouting to stop or significantly control the aforementioned pipe leak, (b) flow bypass, and (c) construction of a bulkhead at the grit chamber. Each of these activities will add to the cost of this approach and require consideration.

On May 2, 2023, the City met with representatives of Hazen and Sawyer and Lanzo Construction Company to review the pipe condition and discuss options. Lanzo was requested to provide costs for both the cured-in-place and slip-lining options, and to assess ancillary considerations such as delivery time for the alternative pipe materials.

It is noted that a relatively small number of local contractors have the capability to perform these types of repairs. Since Lanzo is already mobilized and engaged at the job site, and given the urgent nature of the repair, the City's interests may best align with a process of negotiation that could be initiated following receipt of the requested pricing from Lanzo.



Recommendation

Inspection of the 72-inch pipe reveals multiple areas of advanced deterioration along the pipe crown. The most serious of these includes extensive loss of pipe material and a developing failure of the pipe wall with extremely heavy groundwater ingress. These conditions present a risk of imminent pipe collapse and it is recommended that the City initiate corrective action on an emergency basis.

Please confirm that requirement was acknowledge for the price proposed

We are looking for the divers to obtain the following information from entering the inlet chamber of the Injection Well PS:

- Inspection of the 72'' wall piece on the north inlet chamber wall (shown on the drawings) and the pipe connection to it
- Inspection of the concrete wall/obstruction apparent in the Lanzo video at the inlet chamber that extended below the pipe crown to at least the springline of the pipe. Inspection should include measurements of the obstruction in relation to the 72" pipe opening as well as thickness, description of its material (concrete, abandoned form, etc). Photographs/video if possible. Speculation on the potential for its removal by divers in the future.
- Determination, if possible, of the 72" pipe material RCP vs PCCP
- Location of 72'' pipe joints and closure piece within the length of the approximately 30' of 72'' pipe
- Additional detail of the hole at the crown measurements and/or photographs if possible
- A primary objective of the inspection is to assess the feasibility of cured-in-place lining to repair/renew the pipe section. Lanzo is specifically requested to provide an opinion on this question and to identify key concerns and requirements.

The divers will need a ladder to access the influent chamber. Due to the failure already noted at the pipe crown, we do not recommend that the pipe be entered by the diver. We also suggest that the divers be provided with the record drawings Hazen sent previously. We would be happy to meet with them in advance or on site when the divers go over their pre-dive preparations. Please let us know.

Jeff,

The quality of the video will determine the amount of information discernable. Lining would be the most cost effective repair approach but one of the biggest concerns is the obstruction at the IPS side. We would suggest enlisting a firm such as Industrial Divers to enter the IPS influent chamber and investigate the obstruction. From the video we do not know how much of the 72-in diameter opening is obstructed or how thick it is - i.e. whether or not it is feasible to be removed. If water clarity permits, divers may also be able to use an ROV to obtain additional video and assist with a removal plan.

We are looking for the divers to obtain the following information from entering the inlet chamber of the Injection Well PS:

- Inspection of the 72" wall piece on the north inlet chamber wall (shown on the drawings) and the pipe connection to it
- Inspection of the concrete wall/obstruction apparent in the Lanzo video at the inlet chamber that extended below the pipe crown to at least the springline of the pipe. Inspection should include measurements of the obstruction in relation to the 72" pipe opening as well as thickness, description of its material (concrete, abandoned form, etc). Photographs/video if possible. Speculation on the potential for its removal by divers in the future.
- Determination, if possible, of the 72" pipe material RCP vs PCCP
- Location of 72'' pipe joints and closure piece within the length of the approximately 30' of 72'' pipe
- \bullet Additional detail of the hole at the crown measurements and/or photographs if possible
- A primary objective of the inspection is to assess the feasibility of cured-in-place lining to repair/renew the pipe section. Lanzo is specifically requested to provide an opinion on this question and to identify key concerns and requirements.

The divers will need a ladder to access the influent chamber. Due to the failure already noted at the pipe crown, we do not recommend that the pipe be entered by the diver. We also suggest that the divers be provided with the record drawings Hazen sent previously. Jeff,

The quality of the video will determine the amount of information discernable. Lining would be the most cost effective repair approach but one of the biggest concerns is the obstruction at the IPS side. We would suggest enlisting a firm such as Industrial Divers to enter the IPS influent chamber and investigate the obstruction. From the video we do not know how much of the 72-in diameter

opening is obstructed or how thick it is - i.e. whether or not it is feasible to be removed. If water clarity permits, divers may also be able to use an ROV to obtain additional video and assist with a removal plan.
