A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO APPLY FOR AND ACCEPT THE FEDERAL EMERGENCY MANAGEMENT AGENCY AND THE DEPARTMENT OF HOMELAND SECURITY FY2023 ASSISTANCE TO FIREFIGHTERS GRANT IN AN AMOUNT NOT TO EXCEED \$1,400,000.00 TO PURCHASE EQUIPMENT TO REFURBISH THE FIRE RESCUE TRAINING TOWER; AUTHORIZING THE EXPENDITURE OF MATCHING FUNDS IN AN AMOUNT NOT TO EXCEED \$127,272.73; AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE ALL GRANT DOCUMENTS.

WHEREAS, the Fire Rescue and Beach Safety Department desires to apply for the Federal Emergency Management Agency ("FEMA") and the Department of Homeland Security ("DHS") FY2023 Assistance to Firefighters grant in an amount not to exceed \$1,400,000.00 to purchase much needed equipment to repair and refurbish the Fire Rescue training tower; and

WHEREAS, the acceptance of the grant requires a contribution of \$127,272.73 in matching funds which is available in account numbers 334.219901.52200.564530.000104.000.000 and 111.219801.52200.564530.000000.000.000; and

WHEREAS, the Fire Chief recommends that the City Commission authorize the appropriate City officials to submit a grant application for the FEMA and DHS FY2023 Assistance to Firefighters grant.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it authorizes the appropriate City officials to apply for the Federal Emergency Management Agency and Department of Homeland Security FY2023 Assistance to Firefighters grant in the approximate amount of \$1,400,000.00.

Section 3: That the City Manager is authorized to accept the grant, if awarded, provided that the City Manager shall have the discretion to refuse the grant in those

circumstances where he determines it is in the best interests of the City to do so in which case he shall advise the City Commission of his intention to refuse the grant.

Section 4: That upon the Federal Emergency Management Agency and the Department of Homeland Security FY2023 Assistance to Firefighters grant being awarded to the City, and the City Manager accepting the award, the appropriate City officials are authorized to execute all grant documents together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form by the City Attorney.

Section 5: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
