A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING BY SPECIAL EXCEPTION THE PARTICIPATION OF THE BUDWEISER CLYDESDALE HORSES IN THE CITY OF HOLLYWOOD ST. PATRICK'S DAY PARADE AND FESTIVAL ON SUNDAY, MARCH 11, 2018.

WHEREAS, on Sunday, March 11, 2018, for the 19th year, Downtown Hollywood will host its annual St. Patrick's Day Parade and Festival; and

WHEREAS, this annual event features a traditional float parade beginning at 1:00 p.m. featuring an array of floats, pipe and drum corps, marching bands and business entries along with the famous New York Police Department Emerald Society Pipe and Drum Corps; and

WHEREAS, the parade route will wind its way through Downtown beginning at Harrison Street and 21st Avenue, continuing north to Hollywood Boulevard, east to Young Circle, south to westbound Harrison Street and then returning to 21st Avenue; and

WHEREAS, Budweiser wishes to have their Clydesdales participate in the St. Patrick's Day Parade and Festival; and

WHEREAS, the City Code, Section 92.60 (C) "ANIMAL DISPLAYS OR EXHIBITS", provides:

No vertebrate animals shall be displayed for public entertainment or amusement on property owned by the city or on city-owned property under lease, including but not limited to the exhibition of such animals in zoos, on farms, or during competitive races in arenas; however, animals may be displayed on public property for educational purposes, or with special exception approval from the City Commission, so long as the care of such animals during their display conforms to guidelines established by the city in conjunction with the County Humane Society.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and is incorporated in this Resolution.

Section 2: That it approves and authorizes, by special exception, the participation of the Budweiser Clydesdale Horses in the City of Hollywood St. Patrick's Day Parade and Festival on Sunday, March 11, 2018.

Section 3: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
