A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE A THREE-YEAR AGREEMENT FOR THE 2023-2026 SCHOOL RESOURCE OFFICER PROGRAM WITH THE SCHOOL BOARD OF BROWARD COUNTY, FLORIDA, FOR SCHOOL RESOURCE OFFICERS IN LOCAL PUBLIC ELEMENTARY, MIDDLE, AND HIGH SCHOOLS.

WHEREAS, the School Board of Broward County ("School Board") desires to have the City assign School Resource Officers in public elementary schools, middle schools, and high schools located within the City; and

WHEREAS, the City and the School Board understand that the School Resource Officer Program is established for the purposes set forth in Section 230.2318, Florida Statutes, including but not limited to providing assistance in prevention of juvenile delinquency; and

WHEREAS, the City and the School Board realize that the School Resource Officer Program is a wonderful benefit to school administration, students, and the local community as a whole, and is instrumental in facilitating student involvement in community service programs and projects; and

WHEREAS, the City and the School Board desire to enter into an agreement for a School Resource Officer Program for the provision of School Resource Officers in local public elementary, middle, and high schools for the 2023-2024, 2024-2025 and 2025-2026 school years ("Agreement"); and

WHEREAS, the Agreement sets forth the terms and conditions for the assignment of School Resource Officers in public schools; and

WHEREAS, the term of the Agreement commences on August 14, 2023 and concludes in June 2026; and

WHEREAS, the School Board intends to defray a fraction of the City's cost toward the City's School Resource Officer Program by reimbursing the City \$1,622,250.00 for FY23/24, \$1,703,362.50 for FY24/25, and \$1,788,531.00 for FY25/26; and

WHEREAS, the Chief of Police recommends that the City Commission authorize the appropriate City officials to execute the 2023-2026 School Resource Officer Program Agreement with the School Board of Broward County for the assignment of School Resource Officers during the term of the Agreement.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

<u>Section 2</u>: That it authorizes the execution, by the appropriate City officials, of the attached 2023-2026 School Resource Officer Program Agreement with the School Board, together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form by the City Attorney.

<u>Section 3</u>: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
