A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ISSUE BLANKET PURCHASE AGREEMENTS TO THE GOODYEAR TIRE & RUBBER COMPANY, D/B/A GOODYEAR AUTO SERVICE, J & S TIRE AND AUTO CENTER, INC., D/B/A FLEET TIRE TRUCK AND AUTO, AND EARL W. COVARD, D/B/A BOULEVARD TIRE CENTER, AUTHORIZED DEALERS, FOR THE PURCHASE OF TIRES, TUBES AND SERVICES BASED ON THE FLORIDA STATE CONTRACT FOR TIRES BID AWARD #25172500-19-ACS FOR AN ESTIMATED ANNUAL EXPENDITURE OF \$310,000.00 IN ACCORDANCE WITH SECTION 38.41(C)(5) OF THE CITY'S PROCUREMENT CODE (PIGGYBACK).

WHEREAS, tires required for all Police and general service vehicles for City vehicles are purchased with Goodyear tires based upon specifications by the manufacturer for quality, reliability, speed rating and warranty; and

WHEREAS, tires required for all general vehicles and equipment for the City are purchased with Bridgestone tires based upon specifications by the manufacturer for quality, reliability, speed rating and warranty; and

WHEREAS, the requested automobile, trucks and equipment tires and related services were competitively bid through the Florida State Contract pursuant to Bid Award Number 25172500-19-ACS, and the term of the contract is from April 1, 2019 through March 31, 2024; and

WHEREAS, Section 38.41(C)(5) of the City's Purchasing Ordinance allows the Chief Procurement Officer to procure, without following formal solicitation procedures, all goods, supplies, materials, equipment, and services that are the subject of contracts with the State, its political subdivisions, the United States government, other governmental entities, or a corporation not for profit whose members are governmental entities, public officers, or any combination thereof ("piggyback"), provided that the goods, supplies, materials, equipment, or services are the subject of a price schedule negotiated by the entities listed above and is based strictly on competitive bids, quotations, or competitive proposals and not on any preference, and utilization of other governmental entities' contracts shall be permitted only during the term of the other governmental entity's contract; and

WHEREAS, it is the recommendation of the Public Works Director to approve the issuance of Blanket Purchase Agreements with Goodyear Auto Service, Fleet

Tire Truck and Auto and Boulevard Tire Center, for the purchase of tires, tubes and services; and

WHEREAS, funding for these agreements has been provided in the FY 2022 Operating Budget, in the following Public Works Fleet Maintenance account numbers:

557.510101.51900.546420.000000.000.000 for Police fleet, and will be budgeted in subsequent fiscal years.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the forgoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and authorizes the issuance, by the appropriate City officials, of a Blanket Purchase Agreement to Goodyear Auto Service, together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 3: That it approves and authorizes the issuance, by the appropriate City officials, of a Blanket Purchase Agreement to Fleet Tire Truck, together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 4: That it approves and authorizes the issuance, by the appropriate City officials, of a Blanket Purchase Agreement to Boulevard Tire Center, together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 5: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
