

RESOLUTION NO. R-2006-361

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, ESTABLISHING A GREEN TEAM ADVISORY COMMITTEE, PROVIDING FOR THE PURPOSE AND DUTIES OF THE COMMITTEE; PROVIDING FOR THE NUMBER OF COMMITTEE MEMBERS; PROVIDING FOR CRITERIA FOR COMMITTEE MEMBERSHIP AND PROVIDING FOR THE LENGTH OF TERM OF COMMITTEE MEMBERS.

WHEREAS, on September 20, 2006, the Hollywood City Commission created a Green Team Advisory Committee; and

WHEREAS, the Hollywood City Commission wishes to enlist the aid of its residents and businesses to develop initiatives and programs to reduce energy consumption and greenhouse gas emissions, the "Green Team"; and

WHEREAS, this Committee will focus on making recommendations to the City Commission to develop target environmental goals and implementation plans, create educational campaigns, and promote Hollywood's accomplishments; and

WHEREAS, the Committee will be composed of the following members:

- Three (3) representatives from local environmental groups,
- Five (5) representatives citywide,
- One (1) representative of a non-profit group,
- Three (3) representatives from the Hollywood business community,
- One (1) representative from the local education community ; and

WHEREAS, the Committee will have the following ex-officio members:

- Director of Public Utilities or her/his designee,
- Director of Public Works or her/his designee,
- Director of Planning or her/his designee,
- Director of Building and Engineering Services or her/his designee,
- A Hollywood State Representative,
- A Hollywood School Board Representative,
- One (1) representative from Florida Power & Light;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That there is hereby established the Green Team Advisory Committee of the City of Hollywood.

Section 2: Purpose and Duties. The purpose and duties of the Green Team Advisory Committee shall be to make recommendations to the City Commission to develop target environmental goals and implementation plans, create educational campaigns, and promote Hollywood's accomplishments

Section 3: Membership.

- A. The Green Team Advisory Committee shall consist of thirteen (13) members and seven (7) ex-officio members appointed by resolution of the City Commission, who shall serve without compensation at the pleasure of the City Commission. In making appointments, the City Commission shall follow these guidelines:
1. The members will be in the following categories:  
Three (3) representatives from local environmental groups,  
Five (5) representatives citywide,  
One (1) representative of a non-profit group,  
Three (3) representatives from the Hollywood business community,  
One (1) representative from the local education community,
  2. Ex-officio members will include:  
Director of Public Utilities or her/his designee,  
Director of Public Works or her/his designee,  
Director of Planning or her/his designee,  
Director of Building and Engineering Services or her/his designee,  
A Hollywood State Representative,  
A Hollywood School Board Representative,  
One (1) representative from Florida Power & Light
  3. Each member shall be appointed by a majority vote of the City Commission.
  4. The City Manager shall designate a City Staff member to serve as a liaison to the Committee, to aid and assist in the accomplishment of its goals and objectives.
- B. As provided in the City of Hollywood Code of Ordinances, Section 37.255, the term of each member shall be three years.

Section 4: That all resolutions or parts of resolutions in conflict herewith, be and the same are hereby repealed to the extent of such conflict.


RESOLUTION ESTABLISHING COMPOSITION OF GREEN TEAM

Section 5: That this Resolution shall be in full force and effect immediately upon its passage and adoption.


