## RESOLUTION NO.

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE THE ATTACHED CONTRACT BETWEEN GPE ENGINEERING AND GENERAL CONTRACTOR CORP., AND THE CITY OF HOLLYWOOD FOR CONSTRUCTION SERVICES RELATED TO THE REUSE WATERLINE EXTENSION TO SHERIDAN STATION PROJECT IN THE AMOUNT OF \$424,459.32 (CITY PROJECT NO. 13-7070).

WHEREAS, the Department of Public Utilities is extending the reuse water line along Taft Street east of Park Road; and

WHEREAS, the Department of Public Utilities staff completed the design of the Reuse Waterline Extension to Sheridan Station project; and

WHEREAS, on January 28, 2015, the Department of Public Utilities staff advertised the project soliciting for qualified construction services, and on March 5, 2015, eight (8) bid proposals were received at the Office of the City Clerk and were publicly opened at the City of Hollywood Southern Regional Wastewater Treatment Plant with the following results:

WHEREAS, after thoroughly evaluating the bid proposals for compliance with the contract documents, Department of Public Utilities staff determined that GPE Engineering and General Contractor Corp., is the lowest responsive and responsible bidder; and WHEREAS, a Notice of Intent to Award related to the project was posted in the City of Hollywood website, on DemandStar and BidSync, and was sent via email on March 9, 2015 to all the bidders; and

WHEREAS, the posting of the Notice of Intent to Award resulted in no bid protests; and

WHEREAS, funding for the reuse waterline projects has been provided via Resolution No. R-2014-301 which continued the appropriation for previously approved Capital Projects from FY 2014 to FY 2015; and

WHEREAS, funding for the Reuse Waterline Extension is available in account number 42.4000.90715.536.016301; and

WHEREAS, the estimated time to complete the construction services is four (4) months from the Notice to Proceed date;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF HOLLYWOOD, FLORIDA:

<u>Section 1</u>: That it hereby approves and authorizes the execution, by the appropriate City Officials, of the attached contract between GPE Engineering and General Contractor Corp. and the City of Hollywood, together with such nonmaterial changes as may be subsequently agreed to by the City Manager and approved as to form and legality by the City Attorney, in the amount of \$424,459.36; and

<u>Section 2</u>: That this resolution shall be in full force and effect immediately upon its passage and adoption.
