A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE CONTRACT VPR Α WITH CONSTRUCTION CORPORATION FOR CONSTRUCTION SERVICES RELATED TO THE SOUTHERN REGIONAL WASTEWATER TREATMENT PLANT BUILDING "A" WINDOW ADDITION PROJECT, IN THE AMOUNT OF \$118,210.00.

WHEREAS, the Department of Public Utilities ("Department") proposes to install windows in the first floor conference room in Building "A" at the Southern Regional Wastewater Treatment Plant ("SRWWTP") to provide natural light, control the high humidity, and improve the quality of occupant experience; and

WHEREAS, Department staff prepared bid documents with assistance from Bermello Ajamil & Partners, Inc., who provided architectural services for the SRWWTP Building "A" Window Addition project; and

WHEREAS, on July 6, 2021, a Notice of Bid Availability was posted on the City's website and advertised on Bidsync.com in accordance with Section 38.43 of the City's Procurement Code; and

WHEREAS, on August 24, 2021, three bid proposals were received at the Office of the City Clerk and were publicly opened at the offices of the Procurement Division via WebEx meeting, with the following results:

WHEREAS, Bermello Ajamil & Partners, Inc., the Department and Division of Procurement staff thoroughly evaluated the bid proposals for responsiveness and responsibility, and after the evaluation, VPR Construction Corporation was determined to be the lowest responsive and responsible bidder; and

WHEREAS, on August 3, 2021, a Notice of Intent to Award related to the project was posted on the City's website and on Bidsync, and resulted in no bid protests; and

WHEREAS, the Director of Public Utilities recommends that the City Commission approve and authorize the appropriate City officials to execute the attached contract with VPR Construction Corporation in an amount not to exceed \$118,210.00 for construction services related to the SRWWTP Building "A" Window Addition project; and

WHEREAS, funding for this project was included in the amended FY 2022 Capital Improvement Plan, and is available in account number 442.409903.53600.563020.000704.000.000; and

WHEREAS, the estimated time for completion of construction is 180 calendar days from the Notice to Proceed date.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF HOLLYWOOD, FLORIDA:

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

<u>Section 2</u>: That it approves and authorizes the execution, by the appropriate City officials, of the attached contract with VPR Construction Corporation, together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.

<u>Section 3</u>: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
