A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO AMEND THE SUBLEASE AGREEMENT WITH THE BOYS & GIRLS CLUBS OF BROWARD COUNTY, INC. TO DOCUMENT THE PROGRAMMING USE CHANGE AND RENOVATION FOR ADDITIONAL RECREATION SPACE IN THE WEST HOLLYWOOD NEIGHBORHOOD NETWORK CENTER.

WHEREAS, on November 19, 2003, the City and the Boys & Girls Clubs of Broward County, Inc. ("BAGC") entered into a Sublease Agreement in order to lease classroom, office and recreational space in the West Hollywood Neighborhood Network Center ("WHNNC") located at 1111 N. 69<sup>th</sup> Way; and

WHEREAS, BAGC approached the Department of Parks, Recreation & Cultural Arts ("PRCA") requesting to utilize additional space in the WHNNC to expand recreational programming to include programs and activities geared towards the teenage community; and

WHEREAS, PRCA and BAGC worked together to repurpose the layout of the WHNNC, achieving additional recreation space for the BAGC while the WHNNC will continue to serve as offices for PRCA's Parks and Athletics Division: and

WHEREAS, the School Board of Broward County was informed of the proposed changes and is in favor of the proposed renovations; and

WHEREAS, BAGC will pay all costs associated with the WHNNC renovation, including all applicable Broward County School Board, Broward County and City of Hollywood permits and licenses.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

<u>Section 2</u>: That it approves and authorizes the amendment, by the appropriate City officials, of the attached Sublease Agreement with the Boys & Girls Clubs of Broward County, Inc. to amend Exhibit "A", together with such non-material changes as may be acceptable to the City Manager and approved as to form by the City Attorney.
