A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, CHANGING THE REGULAR CITY COMMISSION MEETINGS SCHEDULED IN JUNE, JULY, OCTOBER AND NOVEMBER 2024, SCHEDULING A REGULAR CITY COMMISSION MEETING ON AUGUST 28, 2024, AND CANCELING THE DECEMBER 18, 2024 AND JANUARY 1, 2025 CITY COMMISSION MEETINGS.

WHEREAS, Section 2.04 of the City's Charter provides, in relevant part, that the City Commission shall schedule no fewer than 20 regular meetings per year and shall hold no fewer than 18 regular meetings per year at such times and places as shall be specified by resolution; and

WHEREAS, pursuant to a series of resolutions, the City Commission has adopted its regular meeting schedule as the first and third Wednesdays of each month starting at 1:00 P.M., except during the month of August; and

WHEREAS, due to Juneteenth, the City Commission desires to change the regularly scheduled Wednesday, June 19, 2024 meeting to Tuesday, June 18, 2024, with citizens' comments at 5:00 P.M.; and

WHEREAS, the City Commission desires to add citizens' comments at 5:00 P.M. on the regularly scheduled Wednesday, July 3, 2024 meeting due to moving the July 17, 2024 City Commission meeting; and

WHEREAS, in order to allow more time for next year's fiscal budget preparation, the City Commission desires to change the regularly scheduled Wednesday, July 17, 2024 meeting to Wednesday, August 28, 2024, with citizens' comments at 5:00 P.M.; and

WHEREAS, due to Rosh Hashanah, the City Commission desires to change the regularly scheduled Wednesday, October 2, 2024 meeting to Tuesday, October 1, 2024; and

WHEREAS, due to Sukkot, the City Commission desires to change the regularly scheduled Wednesday, October 16, 2024 meeting to Wednesday, October 23, 2024, with citizens' comments at 5:00 P.M.; and

WHEREAS, due to the Swearing-In Ceremony of the newly elected officials, the City Commission desires to change the start time of the regularly scheduled Wednesday, November 20, 2024 meeting to 11:00 A.M. from 1:00 P.M., with citizens' comments at 5:00 P.M.; and

- WHEREAS, the City Commission desires to add citizens' comments at 5:00 P.M. on the regularly scheduled Wednesday, December 4, 2024 meeting due to cancelling the December 18, 2024 City Commission meeting; and
- WHEREAS, the City Commission desires to cancel the regularly scheduled Wednesday, December 18, 2024 meeting due to the holidays; and
- WHEREAS, the City Commission desires to cancel the regularly scheduled Wednesday, January 1, 2025 meeting due to the holidays.
- NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:
- <u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.
- Section 2: That the regular meeting of the City Commission scheduled on June 19, 2024 shall be rescheduled in the City Commission Chambers at City Hall, 2600 Hollywood Boulevard, to Tuesday, June 18, 2024 at 1:00 P.M., with citizens' comments at 5:00 P.M.
- Section 3: That the regular meeting of the City Commission scheduled on July 3, 2024 shall have citizens' comments at 5:00 P.M.
- <u>Section 4</u>: That the regular meeting of the City Commission scheduled on July 17, 2024 shall be rescheduled in the City Commission Chambers at City Hall, 2600 Hollywood Boulevard, to Wednesday, August 28, 2024 at 1:00 P.M., with citizens' comments at 5:00 P.M.
- <u>Section 5</u>: That the regular meeting of the City Commission scheduled on October 2, 2024 shall be rescheduled in the City Commission Chambers at City Hall, 2600 Hollywood Boulevard, to Tuesday, October 1, 2024, at 1:00 P.M.
- <u>Section 6</u>: That the regular meeting of the City Commission scheduled on October 16, 2024 shall be rescheduled in the City Commission Chambers at City Hall, 2600 Hollywood Boulevard, to Wednesday, October 23, 2024 at 1:00 P.M., with citizens' comments at 5:00 P.M.
- <u>Section 7</u>: That the regular meeting of the City Commission scheduled on December 4, 2024 shall have citizens' comments at 5:00 P.M.
- <u>Section 8</u>: That the regular meeting of the City Commission scheduled on December 18, 2024 shall be cancelled.

 $\underline{\text{Section 9}}\textsc{:}$ That the regular meeting of the City Commission scheduled on January 1, 2025 shall be cancelled.

<u>Section 10</u>: Thereafter, regular meetings of the City Commission shall, unless otherwise provided by resolution, be held on the first and third Wednesdays of each month.

Section 11: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
