A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AMENDING THE SPECIAL PROGRAMS FUNDS (FUND 11 & FUND 64) OF THE FISCAL YEAR 2014 ADOPTED BUDGET (R-2013-275), REVISING AND RECOGNIZING CERTAIN OPERATING REVENUES, AUTHORIZING CERTAIN BUDGETARY APPROPRIATIONS, ADJUSTMENTS AND TRANSFERS AS DETAILED IN THE ATTACHED EXHIBIT 1, AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, certain routine and periodic budgetary appropriations, adjustments, and transfers as well as the reauthorization and reprogramming of funding remaining at the end of FY 2013 in the Special Programs Funds 11 and 64 are appropriate and necessary; and

WHEREAS, operational requirements necessitate certain revisions to the Adopted Fiscal Year 2014 Budget in the Special Program Funds 11 and 64 by recognizing certain additional revenues and appropriating certain funding for expenditures to promote greater productivity, effectiveness, and efficiency; and

WHEREAS, certain programs and services extend from fiscal year to fiscal year and require an uninterrupted and continuing source of appropriated funds in Special Program Funds (Funds 11 and 64) line item accounts to provide necessary and required services and program funding in order to assist staff in meeting program objectives and requirements; and

WHEREAS, in order to provide an uninterrupted and sufficient source of appropriated funds to furnish the needed services and program funding from fiscal year to fiscal year, certain appropriated funds remaining at the end of the 2013 Fiscal Year in accounts identified in the attached Exhibit 1, attached hereto and by reference made a part hereof, require the continuation of the appropriation and the reauthorization of said funds into certain line item accounts for Fiscal Year 2014 in the identified line item accounts as detailed in Exhibit 1 attached hereto and by reference incorporated herein;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Resolution Amending the Special Programs Funds (Funds 11 and 64) of the Fiscal Year 2014 Adopted Budget, Revising and Recognizing Certain Operating Revenues, Authorizing Certain Budgetary Appropriations, Adjustments, and Transfers as Detailed in the Attached Exhibit 1.

Section 1: That the Amendments, Adjustments and Appropriations to the Special Programs Funds (Fund 11 and Fund 64) Operating Budgets of the City of Hollywood for the Fiscal Year beginning October 1, 2013, set forth in detail in Exhibit 1, are hereby approved, adopted and authorized as Amendments to the Special Programs Funds Operating Budget of the City of Hollywood Florida, for the Fiscal Year 2014.

Section 2: That this resolution shall be in full force and effect immediately upon its passage and adoption.
