A RESOLUTION OF THE CITY COMMISSION OF THE CITY FLORIDA. SUPPORTING HOLLYWOOD. IMPLEMENTATION OF COMMUNITY SHUTTLE PROGRAM AND THE ESTABLISHMENT OF FOUR SERVICE ROUTES WITHIN THE CITY; AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXECUTE ALL APPLICABLE PROGRAM DOCUMENTS AND AGREEMENTS ASSOCIATED WITH THE BROWARD COUNTY COMMUNITY SHUTTLE PROGRAM.

WHEREAS, on November 6, 2018, the voters of Broward County approved the Transportation Surtax ballot measure; and

WHEREAS, on April 8, 2021, Broward County Transit ("BCT") established the FY2022 Community Shuttle Program ("CSP") grant application criteria, funding process, and submission deadline of May 21, 2021; and

WHEREAS, the Department of Development Services, Engineering, Transportation and Mobility Division requested funding to implement six community shuttle routes that expanded service in both the eastern and western areas of the City to augment public transportation services provided by BCT and serve a greater number of people to, from, and within the City; and

WHEREAS, on January 5, 2022, the City was notified by BCT that it would fund the following three community shuttle routes proposed by the City and as more specifically depicted on the attached Exhibit "A":

- (1) East Central route between City Hall and Margaritaville Hollywood Beach Resort one vehicle, seven days per week.
- (2) A1A Loop between Hollywood North Beach Park and the Walmart Supercenter, located on East Hallandale Beach Boulevard two vehicles, seven days per week.
- (3) Southeast Loop between City Hall, Young Circle, Jefferson Park, and the Big Easy Casino one vehicle, seven days per week; and

WHEREAS, on November 2, 2022, the City Commission held a public hearing to consider the establishment of the aforementioned routes and approved Resolution R-2022-334 authorizing the City Manager or designee to execute all documents and agreements related to the CSP; and

WHEREAS, on October 13, 2023, the City was notified by BCT that it would fund an additional community shuttle route proposed by the City and as more specifically

depicted on the attached Exhibit "B":

(1) Southwest Loop between Hillcrest, Memorial Hospital, and the Kay Gaither Community Center - one vehicle, seven days per week; and

WHEREAS, to implement the CSP or establish an additional community shuttle route, BCT requires that the City hold a public hearing before its governing body prior to establishing the new community shuttle service routes; and

WHEREAS, funding for this Agreement will be available through Surtax and is contingent on the execution of an Interlocal Agreement between the City and Broward County; and

WHEREAS, subsequent to the public hearing, BCT and the City will enter into an interlocal agreement setting forth the requirements for the operation of the shuttle service as well as the funding of the program from the Broward County 2022 and 2023 Transportation Surtax.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

- <u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.
- <u>Section 2</u>: That it supports the implementation of a CSP and the establishment of four service routes within the City as set forth on the attached Exhibits "A" and "B".
- <u>Section 3</u>: That it authorizes the City Manager or designee to execute all documents and agreements related to the Community Shuttle Program.
- <u>Section 4</u>: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
