TO
UTILITY WORK BY HIGHWAY CONTRACTOR AGREEMENT (LUMP SUM)

THIS AMENDMENT to the Utility Work by Highway Contractor Agreement ("Agreement") is made and entered into on this _____ day of _____, 2019 by and among the City of Hollywood, ("UAO") located in Broward County, Florida, and the Florida Department of Transportation ("FDOT" or "Department"), (collectively "Parties").

WHEREAS, the parties entered into a Utility Work by Highway Contractor Agreement (Lump Sum) ("UWHCA") on or about December 20, 2018 (hereinafter "Agreement") wherein the UAO agreed to pay FDOT, to have FDOT contractor perform certain Utility Relocation work for the relocation of UAO's facilities; and,

WHEREAS, the parties wish to modify the Agreement to correct the summary of quantities and cost to adjust the manhole covers and valve boxes.

NOW THEREFORE, in consideration of the premises and the mutual covenants contained herein the FDOT and the UAO agree as follows:
