A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO APPLY FOR AND IF AWARDED, ACCEPT COPS COMMUNITY POLICING DEVELOPMENT 2016 GRANT FUNDS FROM THE UNITED STATES DEPARTMENT OF JUSTICE TO DEFRAY THE COST OF COMMUNITY POLICING INITIATIVES, TO INCLUDE COSTS ASSOCIATED WITH OVERTIME, COSTS ASSOCIATED WITH PROBLEM-ORIENTED POLICING TRAINING AND TRAVEL, RESEARCH EVALUATION AND EQUIPMENT RELATED TO THE PROGRAM IN AN AMOUNT NOT TO EXCEED \$125,364.00; AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE ANY AND ALL APPLICABLE GRANT DOCUMENTS AND AGREEMENTS; AND, IF AWARDED, RECOGNIZING OPERATING REVENUES, AUTHORIZING BUDGETARY ADJUSTMENTS, EXPENDITURES, AND TRANSFERS AS DETAILED IN EXHIBIT 1 TO THE POLICE GRANT FUND (FUND 13) FOR FY 2017; AND AUTHORIZING THE DEPARTMENT OF FINANCIAL SERVICES TO ESTABLISH ACCOUNT(S) AS MAY BE NEEDED.

WHEREAS, the Police Department is requesting City Commission authorization to apply for and if awarded, accept COPS Community Policing Development 2016 grant funds from the United States Department of Justice; and

WHEREAS, COPS Community Policing Development Office grant funds are available to law enforcement agencies interested in pursuing community policing and crime prevention initiatives for their respective communities; and

WHEREAS, if awarded, the Police Department is seeking COPS Community Policing Development 2016 grant funds to defray the cost of community policing initiatives to include costs associated with overtime, problem-oriented policing training and travel, research evaluation and equipment related to the program; and

WHEREAS, if awarded, the acceptance of said grant funds does not require a contribution of matching funds and will incur no cost to the taxpayers of the City of Hollywood; and

WHEREAS, the Chief of Police recommends that the appropriate City Officials apply for and if awarded, accept COPS Community Policing Development 2016 grant funds from the United States Department of Justice to defray the cost of community policing initiatives in an amount not to exceed \$125,364.00.

WHEREAS, the Fiscal Year 2017 Adopted Budget to be adopted and approved by the City Commission, subsequent to public hearings in September, 2016, will recognize operating revenues, provide appropriations, and permit authorized budgetary adjustments and transfers in the various funds of the City including the Police Grant Fund (Fund 13); and

WHEREAS, the Department of Financial Services is hereby authorized to create certain accounts and to recognize revenue and appropriate grant funding, if awarded as detailed in the attached Exhibit 1;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That it hereby approves and authorizes the appropriate City Officials to apply for COPS Community Policing Development 2016 grant funds in an amount not to exceed \$125,364.00.

Section 2: That the City Manager is hereby authorized to accept said grant, if awarded; provided, however, the City Manager shall have the discretion to refuse the grant in those circumstances where he determines that it is in the best interest of the City to do so in which case he shall advise the City Commission of his intention to refuse the grant.

Section 3: That upon the COPS Community Policing Development grant funds being awarded to the City, and the City Manager accepting said award, the appropriate City Officials are hereby authorized to execute any and all applicable grant documents and Agreements in a form acceptable to the City Manager and approved as to form and legality by the City Attorney.

Section 4: That it hereby authorizes the Department of Financial Services to create certain accounts to recognize revenue and appropriate program funding.

Section 5: That the Amendments, Adjustments and Transfers to the Operating Budget of the City of Hollywood for the Fiscal Year beginning October 1, 2016, relating to the Police Grants Fund, Fund 13, as set forth in detail in Exhibit 1, if awarded, and attached hereto and by this reference made a part hereof are hereby approved, adopted and accepted as Amendments to the Operating Budget of the City of Hollywood, Florida for the Fiscal Year 2017 and the identified Police Grants Fund (Fund 13).

A RESOLUTION AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO APPLY FOR AND, IF AWARDED, ACCEPT COPS COMMUNITY POLICING DEVELOPMENT 2016 GRANT FUNDS FROM THE UNITED STATES DEPARTMENT OF JUSTICE TO DEFRAY THE COST OF COMMUNITY POLICING INITIATIVES.

Section 6: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
