

• By this Agreement, the Parties are coordinating a joint management program for System Waste that are consistent with Sections 163.01, 403.706 (11), (12), (15), and (19), and 403.713, Florida Statues.







Section 6.10 Synopsis

 Authority Counsel. Authority Counsel shall act as a general counsel authorized by the Governing Board and shall not be an: (a) elected official of any party, or (b) employee of any party other than Authority. Authority counsel shall be an attorney licensed through the Sate of Florida and must have substantial experience providing counsel related to recycling and solid waste disposal. Through approval of the Executive Committee, Authority Council may retain special counsel in legal matters and legal conflict except for matters in Section 6.10.2.



Revised Section 8.2.8 Synopsis

• Appoint and make all decisions regarding Authority Counsel including compensation and removal.









Section 19.14 Synopsis

 Provides that any party complying with laws, rules, regulations, etc. enacted AFTER the effective date of the agreement will not be liable to any other party should it be unable to abide by its responsibilities as a result of the change in law, if certain conditions are satisfied.

New

Section 19.15 Synopsis

 Provides that the County may undertake certain actions before the "Formation Conditions" have been met that may be prohibited once those conditions are satisfied, and further allows the County to continue to provide services to entities not covered by the agreement.





Section 19.16 Synopsis

• Provides that the solid waste authority may not take any action, prior to satisfying the Formation Conditions, that result in any financial obligation for any party other than the amounts provided in Section 5.4 of the agreement.





In Summary

The Goal of the Solid Waste Authority:

- Encourage recycling, reduction, reuse and divert solid waste from landfills.
- Support regional solutions with other counties with like priorities and goals as Broward County and their municipalities.
- Conduct comprehensive public education campaigns.
- Engage in and/or support research and development into disposal, reduction, recycling, reuse and utilization of the latest technology to create a sustainable and resilient solid waste disposal and recycling materials processing system.



In Summary

There is an urgent need for regional management of solid waste disposal and recyclables processing.

Through the proposed Interlocal Agreement (ILA), Broward County seeks to partner with the municipalities that are willing to work together to develop and implement a long-term, environmentally sustainable, transparent, economically efficient plan and approach for disposal, reduction, recycling, and reuse of waste generated in Broward County.
