## **DECLARATION OF OFFICIAL INTENT**

## For Reimbursement of Expenditures from a Debt Financing

This is a Declaration of Official Intent under U.S. Treasury Regulations for purposes of Section 103 and 141 to 150 of the Internal Revenue Code of 1986, as amended (the "Code").

- 1. The undersigned, on behalf of the City of Hollywood, Florida (the "Borrower") declares that the Borrower reasonably expects that the capital and other expenditures described in paragraph 2 (the "Project") will be reimbursed with proceeds of a debt financing (as defined in Section 150 of the Code). The maximum principal amount of debt financing expected to be received for the Project is \$1,950,000.00
- 2. Description of capital and other expenditures to be reimbursed.

Expenditures related to certain capital improvement projects contained in the proposed FY 2016 – FY 2020 Capital Improvement Program relating to the following categories of capital projects:

- Johnson Street Complete Street Project
- City Hall HVAC Replacement Project
- Public Safety Fleet Replacement Project

The undersigned has been authorized by the Borrower to make and sign this Declaration on behalf of the Borrower.
