A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, ADDING AMERICAN LEGION HOLLYWOOD POST 92, INC. TO THE LIST OF CHARITIES AND FUNDRAISING EVENTS FORMALLY APPROVED BY RESOLUTION NO. R-2017-293 FOR THE SOLICITATION OF FUNDS PURSUANT TO THE COUNTY'S CODE OF ETHICS FOR ELECTED OFFICIALS.

WHEREAS, on October 4, 2017, the City Commission of the City of Hollywood, Florida adopted Resolution No. R-2017-293 formally approving charities and fundraising events for the solicitation of funds pursuant to the County's Code of Ethics for Elected Officials (the "Code of Ethics"); and

WHEREAS, the City Commission wishes to add American Legion Hollywood Post 92, Inc. ("American Legion") to the list of formally approved charities; provided, however, that it is not clear that American Legion is a charity under the Internal Revenue Code (the "IRC"); and

WHEREAS, to be approved for the solicitation of funds pursuant to the Code of Ethics, an organization must be a charity under the IRC.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and incorporated in this Resolution.

<u>Section 2</u>: That it formally adds American Legion Hollywood Post 92, Inc. to the list of formally approved charities for the solicitation of funds pursuant to the Code of Ethics, subject to the requirement that to be approved for the solicitation of funds pursuant to the Code of Ethics, American Legion must be a charity under the IRC.
