3. Detailed description of the product/service's function and purpose. The Filter Feed Pump Strainers are located upstream from the filter feed pumps (on the discharge side) in between the Pumps and the sand filters. These two strainers screen any remaining inorganic floating solids in the effluent pre-treated water before it gets to the sand filters. After exiting the sand filters, this water will later be reused internally as non-potable water within the WWTP for seal water systems, cleaning, chlorine gas dosing, belt presses, pumps, clarifiers spraying system, and as reclaimed water for ponds and irrigation systems throughout the City of Hollywood.



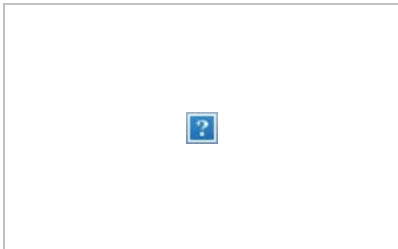

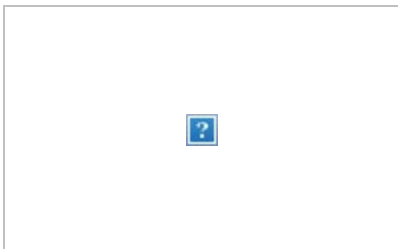
