A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, REAFFIRMING ITS APPROVAL OF RESOLUTION NO. R-2021-058 THAT AUTHORIZED APPROPRIATE CITY OFFICIALS TO SUBMIT A PRE-APPLICATION GRANT PACKET FOR COMMUNITY DEVELOPMENT BLOCK GRANT-CORONAVIRUS FUNDS FROM THE FLORIDA DEPARTMENT OF ECONOMIC OPPORTUNITY IN THE AMOUNT OF \$760,335.00.

WHEREAS, on March 3, 2021, the City Commission passed and adopted Resolution No. R-2021-058, authorizing the appropriate City officials to submit a pre-application grant packet for community development block grant-coronavirus funds from the Florida Department of Economic Opportunity ("DEO") in the amount of \$760,335.00; and

WHEREAS, based upon City staff and the Community Advisory Board's recommendation, the City Commission, pursuant to Resolution No. R-2021-058, approved the allocation of CDBG-CV2 funds as follows:

Small Business Asst.	\$250,000.00
HVAC Replacement Martin Luther King (MLK)	\$200,000.00
HVAC Replacement Washington Park	\$140,000.00
Laptops for the provision of Public Services MLK, Washington Park, Kay Gaither, Driftwood	\$ 80,000.00
Wiring and Networking for Community Centers MLK, Washington Park, Kay Gaither, Driftwood	\$ 70,000.00
General Administration	\$ 20,335.00
Total CDBG-CV2 Investment	\$760,335.00

WHEREAS, subsequent to Resolution No. R-2021-058 being passed and adopted by the City Commission, City staff was advised that due to the diversity of the population of the City, it is necessary and appropriate to re-notice a public hearing relating to the adoption the proposed uses of funds in additional languages to ensure that each Hollywood resident has the opportunity to comment on the housing and community development needs related to the coronavirus pandemic; and

WHEREAS, the Florida Department of Economic Opportunity grant requires the City to submit a pre-application grant packet that describes the proposed activities after a public hearing that allows citizens to comment on the housing and community development needs related to the coronavirus pandemic; and

WHEREAS, proper notice has been provided to the citizens of the City prior to this public hearing in accordance with DEO Public Notices and Hearing requirements; and

WHEREAS, the Community Development Division is recommending that the City Commission reaffirm its approval of Resolution No. R-2021-058 for the submission of the pre-application grant packet to be consistent with the public notification and public hearing requirements.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That Resolution No. R-2021-058 is reaffirmed, and the appropriate City officials are authorized to submit the pre-application grant packet for Community Development Block Grant program funding from the Florida Department of Economic Opportunity as set forth in Resolution No R-2021-058 and this Resolution.

Section 3: That the City Manager is designated as the authorized representative to provide the assurances and commitments required by the pre-application grant packet.

Section 4: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
