A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE A REVOCABLE LICENSE AGREEMENT WITH BROWARD COUNTY FOR SCHOOL ZONE SPEED DETECTION SYSTEMS AT NORTH 21ST AVENUE, DAVIE ROAD EXTENSION, AND SHERIDAN STREET.

WHEREAS, on May 1, 2024, the City Commission approved O-2024-05 creating Chapter 78 of the Code of Ordinances entitled Speed Detection Systems in School Zones; and

WHEREAS, Chapter 78 included the approved locations for Automated Speed Detection Systems in school zones, some of which are located on County roads; and

WHEREAS, Broward County owns the portions of North 21<sup>st</sup> Avenue, Davie Road Extension and Sheridan Street where the City desires to install Automated Speed Detection Systems; and

WHEREAS, the County is willing to provide the City nonexclusive access and use of the areas to install, operate and maintain Automated Speed Detection Systems; and

WHEREAS, the Chief of Police recommends that the City Commission approve and authorize the execution of the Revocable License Agreement with Broward County for school zone detection systems at North 21<sup>st</sup> Avenue, Davie Road Extension, and Sheridan Street.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and authorizes the execution, by the appropriate City officials, of the attached Revocable License Agreement with Broward County for School Zone Speed Detection systems at North 21<sup>st</sup> Avenue, Davie Road Extension, and Sheridan Street, together with such non-material changes as may subsequently be agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 3: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
