SUBJECT:	Increasing (Liquid Oxygen Supply) Quantities related to Blanked Purchase Order #B002566 (Air Liquide Industrial, U.S. Lp)	

ISSUE:

The Department of Public Utilities (DPU) requests increasing the quantities in the current Blanket Purchase Order between Air Liquide and the City of Hollywood (#B002566) due to emergency repairs to the Cryogenic Plant at the Southern Regional Wastewater Treatment Plant (SRWWTP).

EXPLANATION:

On October 17, 2014, during the final phases of the annual Cryogenic Plant turn-around, the contractor working on the turn-around, Solutionswerks, Inc. informed that one of the main components of the plant had malfunctioned and he needed to perform additional troubleshooting in the system. During the weekend, Solutionswerks worked on different troubleshooting scenarios but there were not able to bring the plant back in service. Due to the sensitive and critical role of the Cryogenic System in the overall wastewater treatment process, the Department of Public Utilities considers the malfunctioning of the cryogenic plant an emergency, and the repairs must take place immediately.

The DPU contacted Procurement Services and informed the director of the situation, and the DPU immediately began contacting companies to performed preliminary evaluation or troubleshooting, and to provide a recommendation for repairs. After several attempts, the DPU was able to speak to reach an understanding with AirSep Process and Controls, LLC., a specialized company out of Niagara Falls, NY. Currently the DPU is seeking authorization to proceed with the emergency repairs to the coldbox.

While the DPU obtains the related authorizations, the constant supply of liquid oxygen required for the continuous treatment of wastewater must be guaranteed. The DPU has an established blanket purchase order (BPO) with Air Liquide for the supply of liquid oxygen. The ceiling amount for this existing BPO is \$154,620.00, which translates to approximately 955.5 tons of liquid oxygen at \$161.82.

DPU staff is requesting increasing the amount of the BPO by an additional \$293,946.03, to secure approximately 1,816.5 tons of liquid oxygen supply for six (6) weeks. The total additional expenditures in liquid oxygen however will depend on how fast the cryogenic plant is repaired.

Air Liquide has confirmed that currently they can supply the excess liquid oxygen, while the Cryogenic Plant is out of service, honoring the previously established prices in the BPO.

RECOMMENDATION:

The Department of Public Utilities (DPU) recommends increasing the current quantities in the blanket purchase order between Air Liquide and the City of Hollywood due to emergency repairs to the Cryogenic Plant at the Southern Regional Wastewater Treatment Plant (SRWWTP), in an amount of \$293,946.03.
