The Railway has completed our field inspection of all grade crossings on our line and compiled a list of crossings for our 2017 Grade Crossing Maintenance Program.



On behalf of Florida East Coast Railway, please see the attached Notice of Intent regarding the FEC 2017 Grade Crossing Maintenance Program.

The Railway has recently completed its annual field inspection of all grade crossings throughout the corridor and have compiled a list of crossings which will require maintenance to be performed. The attached list of crossings fall within your jurisdictional responsibility and are scheduled to be re-worked in the upcoming year beginning January 1, 2017. With each crossing you will find an estimated cost for use in budgeting for the crossing maintenance. It should be noted this is an estimate only and reflects the present cost of material and labor, all charges will be billed on an actual cost basis.

PLEASE NOTE:

- FEC is currently coordinating with All Aboard Florida officials regarding construction scheduling and future proposed work in an effort to minimize the impact to the public that would otherwise cause multiple roadway closures and duplicated work efforts during this required crossing maintenance.
