A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, CONSIDERING THE CONTINUANCE/SUNSETTING OF THE FOLLOWING ADVISORY BOARDS: AFFORDABLE HOUSING ADVISORY COMMITTEE, AFRICAN AMERICAN ADVISORY COUNCIL, ARTWORK SELECTION ADVISORY COMMITTEE, EDUCATION ADVISORY COMMITTEE, GENERAL OBLIGATION BOND OVERSIGHT ADVISORY COMMITTEE, MARINE ADVISORY BOARD, PARKS, RECREATION & CULTURAL ARTS ADVISORY BOARD, SISTER CITIES ADVISORY COMMITTEE, SUSTAINABILITY ADVISORY COMMITTEE, AND THE YOUNG CIRCLE ARTSPARK ADVISORY BOARD.

WHEREAS, Section 37.25 of the Code of Ordinances establishes the uniform regulations relating to City Advisory Boards, including the sunsetting and/or continuance of boards; and

WHEREAS, pursuant to R-2024-078, the City Commission by majority vote continued the following Advisory Boards: Affordable Housing Advisory Committee, African American Advisory Council, Artwork Selection Advisory Committee, Education Committee, General Obligation Bond Oversight Advisory Committee, Marine Advisory Board, Parks, Recreation & Cultural Arts Advisory Board, Sustainability Advisory Committee, and the Young Circle ArtsPark Advisory Board; and

WHEREAS, the above referenced Advisory Boards are scheduled to be sunsetted this year and therefore must be considered by the City Commission at its March 5, 2025, meeting in order for the City Commission to determine whether to sunset the boards or by a majority vote continue the operation of the boards; and

WHEREAS, the Sister Cities Advisory Committee has been in existence for more than one year and must be considered for continuance along with the above-referenced advisory boards; and

WHEREAS, staff has recommended the sunsetting of the Young Circle ArtsPark Advisory Board, as their responsibilities can be consolidated within the Parks, Recreation, and Cultural Arts Advisory Board; and

WHEREAS, the Hollywood Centennial Celebration Committee has been in existence for more than one year and is set to sunset on January 31, 2026.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA.

Section 1: The foregoing “WHEREAS” clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: The City Commission hereby approves the continuance or sunsetting of the following Advisory Boards as of this date:
