A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ISSUE A PURCHASE ORDER TO CENTURION PARTNERS HEALTH AND FITNESS LLC D/B/A FITNESSSMITH FOR POLICE HEADQUARTERS GYM EQUIPMENT IN AN AMOUNT UP TO \$200,000.00, BASED UPON CONTRACT #FY22-128 FOR GYM EQUIPMENT, IN ACCORDANCE WITH SECTION 38.41(C)(5) OF THE PROCUREMENT CODE.
(PIGGYBACK)

WHEREAS, the Police Department desires to purchase indoor gym equipment to replace aged equipment and outfit the gym in the new police headquarters; and

WHEREAS, the gym equipment was competitively bid by the Broward County School Board through Invitation to Bid on September 19, 2016, and awarded to Centurion Partners Health and Fitness, LLC d/b/a Fitnessmith ("Fitnessmith") under Contract #FY22-128; and

WHEREAS, the current term of Contract #FY22-128 is from November 1, 2025, through October 31, 2026; and

WHEREAS, Fitnessmith has agreed to extend to the City the same pricing under the terms and conditions set forth in Contract #FY22-128; and

WHEREAS, the indoor gym equipment will be acquired during the transition to the new Police Headquarters and is quoted for \$167,559.46, and the department is planning \$32,440.54 for contingency in consideration of future structural or design changes during the transition; and

WHEREAS, Section 38.41(C)(5) of the Procurement Code allows the Chief Procurement Officer to procure, without formal solicitation procedures, all goods, supplies, materials, equipment, and services that are the subject of contracts with the state, its political subdivisions, the United States government, other governmental entities, or a corporation not for profit whose members are governmental entities, public officers, or any combination thereof ("piggyback"), provided that the goods, supplies, materials, equipment, or services are the subject of a price schedule negotiated by the entities listed above and is based strictly on competitive bids, quotations, or competitive proposals and not on any preference and such utilization of other governmental entities contracts shall be permitted only during the term of the other governmental entity's contract; and

WHEREAS, the Chief of Police and Chief Procurement Officer recommend that the City Commission approve and authorize the issuance of a Purchase Order to Centurion

Partners Health and Fitness, LLC D.B.A. Fitnessmith for Police Headquarters Gym Equipment in an amount up to \$200,000.00; and

WHEREAS, funding for this project was included in the amended FY 2026 Capital Improvement Plan, and is available in account number 334.209901.52100.564531.001190.000.000.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA.

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and authorizes the issuance, by the appropriate City officials, of a Purchase Order to Centurion Partners Health and Fitness, LLC d/b/a Fitnessmith, together with such non-material changes as may subsequently be agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 3: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
